Respected Sir,

With due respect I Mira Sanyal Wife of Late Ajit Sanyal residing at Nabagram, within S.M.C. Ward No:33, P.S.NJP, District-Jalpaiguri, West Bengal, would like to state as follows:-

1. I am a widow and a senior citizen and at present my age is 75 years and I reside at my own house situated at Nabagram, within S.M.C. Ward No:33, P.S.NJP, District-Jalpaiguri, West Bengal in joint mess.
2. That I have three sons namely Bapi Sanyal, Raju Sanyal and Bittu Sanyal and a daughter named Soma Bhowmik.
3. That my eldest son named Bapi Sanyal, middle son Raju Sanyal, their wives named Pratima Sanyal W/O Bapi Sanyal and Susmita Sanyal W/O Raju Sanyal and my daughter Soma Bhowmik take good care of me as I am completely dependent.
4. That taking advantage of my old age and dependency, my youngest son Bittu Sanyal and his wife Maman Sanyal from 2016 have continuously inflicted inhuman mental and physical torture upon me and my husband with the sole motive of occupying and grabbing the entire residential house and land depriving the other legal heirs of mine and compelling us to register the property in their name

forcefully and illegally. It is pertinent to mention here that unable to bear such mental torture my husband Ajit Sanyal passed away on 26-08-2016. It is not out of place to mention here that since 2016 I have made several complaints to the police station but none of them have been fruitful.

5. **That** Maman Sanyal spat upon me whenever I performed my religious rituals in the house. Also on several occasions, both my younger son and his wife locked me in a room without providing me any food or water and I had to be rescued by my other sons (Bapi Sanyal, Raju Sanyal) and daughter-in-laws namely Pratima Sanyal, Susmita Sanyal . A complaint regarding this specific act was previously lodged before the N.J.P Police Station and the Siliguri Commissionerate Siliguri on 03-08-2018.
6. **That** in the months of July 2018 and August-2018, my youngest son and his wife, along with unknown miscreants, attacked and forced me to sign blank documents to grab the property. But somehow I was rescued by my daughter-in-laws namely Pratima Sanyal and Susmita Sanyal.
7. **That** when confronted, , my youngest son and his wife blatantly threatened me that they would forcefully take over the house and "make me beg for alms." My son has also threatened to forge the property documents in his name, and , his wife has threatened to file further false cases.


8. **That** in the month of May 2025 my son Bittu Sanyal and my daughter in-law Maman Sanyal pelted stone at me and resultantly I sustained some injuries. It is pertinent to mention here that when the I protested against these illegal acts recently in the month of June 2025 and July 2025 my son Bittu Sanyal, while in a drunk state, physically assaulted the me and chased me with a 'Bhojali', amounting to grave criminal intimidation and assault.
9. Furthermore, my youngest son and his wife have demonstrated a pattern of harassment through the misuse of legal processes, having filed multiple false cases against me and my family members, including:
- o Bhakti Nagar P.S Case No: 1417/2015 dated: 07-10-2015 (wherein all the family members were honorably acquitted on 01-03-2024 by the Ld. Judicial Magistrate (2nd) Court at Jalpaiguri).
 - o Bhakti Nagar P.S Case No: 1160/2015 dated: 22-08-2015.
 - o NJP P.S. Case-25/2022 dated: 06-10-2022.
 - o NJP P.S. Case-523/2025 dated: 31-07-2025.
10. That my youngest son Bittu Sanyal, His wife Maman Sanyal and his daughter named Eirsha Sanyal file false cases against me, my other two sons, my other two daughter-in-laws, my own daughter and these constant, false cases are a medium of harassment being used to compel me to register the property in my youngest son and his wife's names and because of such false cases at this age I go to Court to take bail. Moreover it is pertinent to mention here that among these cases there are cases wherein they have stated that they have filed a case due to misunderstanding and in this way they are misusing the law.
