I'm producing herewith 01 (one) accused person namely Arun Biswakarma (24yrs) S/O Raju Biswakarma of Hariya Budhabarey, PS+Dist- Jhapa, Nepal, A/P Gas Godown Sukantapally, PS Matigara, Darjeeling, under arrest and the following articles under seizure viz (i) 01 semi auto pistol fire arms, with barrel, slide, trigger, trigger gard, fireing pin, hammer, pistol grip, one magazine (loaded with two live ammunition) approx measuring 20cm - Marked as Exhibit 'A' and (ii) 02 (two) rounds of live ammunition- Marked as Exhibit - 'B'. I, SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Arun Biswakarma (24yrs) S/O Raju Biswakarma of Hariya Budhabarey, PS+Dist- Jhapa, Nepal, A/P Gas Godown Sukantapally, PS Matigara, Darjeeling, to the effect that on 17.11.2025 at 00:45hrs I received a specific secret source information that one person would come to Siliguri Junction, near Heritage Hotel area under PS- Pradhan Nagar, dist. Darjeeling with illegal firearms with a view to sell the same to his designed customer or to commit any heinous crime. Accordingly, I diarized the information in PS General Diary vide Pradhan Nagar PS GDE No. 950 dated 17.11.2025 and informed the fact to you, and as per your kind order and direction myself along with ASI Biplab Kr Das, ASI Bikash Roy and force left for Siliguri Junction, near Heritage Hotel under P.S- Pradhan Nagar, Dist. Darjeeling with an investigation kit to work out the information by Govt. vehicle. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. On the way, I requested night RT Van officer SI Debabrata Khan to come near Heritage Hotel, Siliguri Junction to accompany us. At around 01:05 hrs we arrived near Heritage Hotel and after a while SI Debabrata Kahn arrived there and accompanied us. I requested two independent persons namely (i) Md. Azad Quraishi (24yrs) S/O Md Azgar of Old Matigara Road, Siliguri Junction, W/No. 01, Gate Bazar, PS Pradhannagar, Dist Darjeeling and (ii) Ashish Chand Ram (25yrs) S/O Ram Chandra Ram of Old Matigara Road, Siliguri Junction, W/No. 01, Gate Bazar, PS Pradhannagar, Dist Darjeeling, and shared the information I have, and requested to remain present and act as witness during search and seizure if required upon which they agreed. Then, I contacted my source and he informs me that the suspect is arriving shortly. There after at about 02:00hrs we noticed that one person was coming towards Darjeeling more side, by walking, and being identifying by my source we cordoned the place from every corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we were able to apprehend him in front of Heritage Hotel under PS- Pradhan Nagar, Dist. Darjeeling. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. As per source information he is possessing firearms and ammunition hence immediately, I searched the said detained person and recovered the following articles viz (i) 01 semi auto pistol fire arms, with barrel, slide, trigger, trigger gard, firing pin, Hammer, pistol grip, one magazine loaded with two live ammunition) approx measuring 20cm and (ii) 02 (two) rounds of live ammunition. On demand he failed to produce any document in respect of fire Arm and ammunition which was recovered from his exclusive and conscious possession which was hidden in his back side. Accordingly, I seized the above-mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledged by the accused person. The search seizure and label were made in between 02.20 hrs to 02.50 hrs on 17.11.25 at the spot under the coverage of videography as per norms of BNSS. On further interrogation he admitted that he came there to deliver the same to his design customer for his wrongful gain.

Thus, when his involvement in carrying and possessing illegal Firearms and ammunition was established, accordingly I arrested him under proper memo of arrest and observed all the formalities for violating the norms of Arms Act. I informed him regarding grounds of arrest and also issued a copy of memo of arrest and ground of arrest to him.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Arun Biswakarma (24yrs) S/O Raju Biswakarma of Hariya Budhabarey, PS+Dist- Jhapa, Nepal, A/P Gas Godown Sukantapally, PS Matigara, Darjeeling is desperate and dangerous in nature, as he was carrying the said Fire arm and live ammunition with an objective to sell the same or to commit any heinous crime in the locality. As he wilfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Arun Biswakarma (24yrs) S/O Raju Biswakarma of Hariya Budhabarey, PS+Dist- Jhapa, Nepal, A/P Gas Godown Sukantapally, PS Matigara, Darjeeling under proper section of law and may arrange to cause its investigation.
