Subject: - F.I.R.

Sir,

In producing herewith the following accused person namely Dipak Mahato (34), S/O Shankar Mahato of Vikash Hotel, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following seized articles under proper seizure list viz :- (i) One golden/brown bag of Basmati rice printed as "Swad Shree" containing containing 12 bottles of "KINGFISHER STRONG BEER" each bottle containing 650 ml i,e total (12 x 650 ml = 7.800ltrs) marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1". I, SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the accused person namely Dipak Mahato (34), S/O Shankar Mahato of Vikash Hotel, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 17.11.25 at 16.55hrs myself along with force left the PS to perform PC Mobile van duty vide Pradhan Nagar PS GDE No. 986 dated 17.11.25. During my duty at around 18.10 hrs I received source information that one Dipak Mahato (34), S/O Shankar Mahato of Vikash Hotel, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling is selling and storingh illicit liquor illegally in his hotel styled as "Vikash Hotel" without any valid documents. Accordingly, I informed the matter to you over phone.

As per your kind order and direction, I along with SI Goutam Mallick, ASI Prabal Sarkar along with force all of Pradhan Nagar PS left for Vikash Hotel, Dagapur under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. On arriving at Dagapur, I contacted with my source and as identified by him, I along with other officers and force entered into the hotel of said Dipak Mahato (34), S/O Shankar Mahato of Vikash Hotel, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling and conducted a raid and managed to detain him. I informed him about the information in my hand and during interrogation interrogotation he disclosed that he is selling and store liquor at his above named hotel without any valid documents. On search the above noted illicit liquor was recovered from the hotel. On demand he failed to produce any valid documents or licence to possessising/storing such illicit liquor at the hotel. As he willfully violated the norms of Bengal Excise Act hence, I seized the above noted illegal liqior from his possession under proper seizure list in presence of available independent witnesses. The entire process of search and seizure was made in between 18.40 hrs to 19.25 hrs under the coverage of videography. Subsequently, I arrested the above noted detained person namely Dipak Mahato (34), S/O Shankar Mahato of Vikash Hotel, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Dipak Mahato (34), S/O Shankar Mahato of Vikash Hotel, Dagapur, PS- Pradhan Nagar, Dist. Darjeeling for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.


