I was teaching at my coaching center and my phone rang at 8:43 pm. It was my father's call but an unknown voice informed me that a high speed scooty stroke my father's bicycle and escaped hurriedly towards Gyanjoti More without any moral responsibility and he is severely bleeding in his head and eyes. I was directed to reach soon at the accident spot near Mahbart High School. The locals handovered a detached number plate bearing vehicle no: **KA 04KH7402** and informed that it belongs to the striking vehicle. I admitted my father at **A.H IVF Centre, Himachal Bihar, Matigara** at **9:14 pm**. He is under treatment now.
