Sub- Complaint against my husband namely Santosh Darnal for
committing physical and mental abuse against me.

Sir,

This is to inform you that I Smt. Kabita Biswakarma Darnal, wife of Santosh Darnal, aged about 38 years, housewife by profession, resident of Paschim Toroyok Busty, P.O. Bagora, P.S. Kurseong, Dist- Darjeeling, Pin- 734224, presently residing at Utsab Apartment, Phase-1, Kalamjote, P.O. Kadamtala, P.S. Matigara, Dist- Darjeeling, am law abiding citizen and I beg to state you that on 12/07/2007 I got married to one Santosh Darnal, S/o Nar Bahadur Darnal, now retired army Lance Naik, now serving in Indian Air Force as a civilian and since then I am residing in my matrimonial house with my husband and my son namely Samavid Darnal and my daughter namely Saanvi Darnal.

That on 16/11/2025 at around 01:00 pm in the afternoon, while I was busy doing my household chores my husband namely Santosh Darnal came at our residence, intoxicated and started abusing me with filthy languages and demanding lunch but ignoring his filthy abuses I prepared him lunch and when I tried to serve him with his food he again started to abuse me stating he would not eat my handmade food and started abusing me even with worst languages and harming my modesty. Although I requested him not to create any chaos and have his lunch peacefully, he did not even acknowledge any of my request he started destroying my furniture's in which he shattered our LCD television, glass dining table, wardrobe and other household utensils, witnessing such a situation I kindly requested him verbally not to do so but he even got more furious and started to slap me in my face and head, he even caught my hair dragging me across my room and punched me in my head and stomach areas, receiving such heavy blows I was in deep agony and shock and

I was unable to defend myself from my husband's cruel act. I somehow gained some courage and tried to call/shout for help but my husband choked my mouth and forced me to remain silent and threatened me that today he will kill me by chopping my head off, witnessing such an violent and cruel act I was shocked to my core and was completely trembled but my husband above named without showing any mercy still continued to thrash me with blows and filthy/threatening statements.

After a while I somehow gained some strength and made myself free from my husband's grip as he was tired by then and with multiple injuries and trauma's I locked myself in other room of our residence and called in the emergency helpline number and after a while police came at our residence and took control of the situation. It is pertinent to mention here that these tortures are being made upon me from prolonged period of time (after 2 years from our date of our marriage) and in past situations my husband had beaten me with his leather belt and caused me many bodily injuries which caused immense bleedings and pain, but I still tolerated all of his violent activities just to save our marriage and maintain our reputation in front of our family and children.

But now finding no other alternatives I am writing you this written complaint and requesting you to take appropriate and strict actions against my husband namely Santosh Darnal for committing horrific and violent physical and mental abuses against me for a prolonged period of time and save me from his tortures at the earliest for which I shall remain forever obliged.
