Accordingly, I diarised the information vide DD SPC, GDE No. 111 dated 19.11.2025 and inform the information to ACP, DD, SPC, Siliguri. As per order of ACP DD SPC, I along with SI Basudeb Guha, ASI Sagar Das, Const-686 Arup Saha, Const- 670 Ratan Roy and CV-150 Bikash Thakur all of DD SPC left DD office with Govt. Vehicle to verify the veracity of the source information.

KSP 19/11/2025

At about 20.25 hrs we reached at Matigara-Siliguri Asian Highway near Siliguri Gate under Matigara PS and as per the source information at about 20.50 hrs we found the above mentioned vehicles coming from Matigara side and accordingly we stop the Vehicles . I disclosed our identity to the drivers of the vehicles and stated the ground for detaining the vehicles . We found that the vehicles are loaded with river bed materials . On question the drivers disclosed their name and address as above. On demand they could not produce any documents in support of the possession/ carrying of such quantity of river bed materials and admitted that they along with others loaded the river bed materials from Balasun River by fraudulent means or by stolen means. Accordingly , I seized all the above mentioned six vehicles loaded with river bed materials under proper seizure list in presence and duly signed by the witnesses under proper videography and arrested both the above mentioned person U/S 35 of BNSS. The whole process of seizure was made in between 21.05 hrs hrs and 22.10 hrs.
