Sir,

In producing herewith the following accused person namely Sandhu @ Sanu Parti (41yrs) S/O Manshingh Parti, of Debidanga, Champasari, near Uday Sporting Club, PS- Pradhan Nagar, Dist. Darjeeling under arrest and the following seized articles under proper seizure list viz :- (i) 08 bottles of "KINGFISHER STRONG BEER" each bottle containing 650 ml i,e total (08 x 650 ml =5.200 ltrs) marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1", ii) 06 bottles of "HIMALAYAN GOLD 60UP" containing 600ml. in each bottle i,e total (06 x 600ml = 3.600 ltrs), and marked as exhibit "B", out of which one bottle of the same taken as sample and marked as exhibit "B1", iii) 08 bottles of Mc Dowells No1 Luxury blended whisky containing 180ml in each bottle i,e toatal (08 x 180ml = 1.440 ltrs) and marked as exhibit "C" out of which one bottle of the same taken as sample and marked as exhibit "C1" and iv) 04 bottles of Mc Dovells No1 Original whisky containing 180ml in each bottle i,e total (04 x 180= 720 ml) and marked as exhibit "D", and out of which one bottle of the same taken as sample and marked as exhibit "D1".

I, SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the accused person namely Sandhu @ Sanu Parti (41yrs) S/O Manshingh Parti, of Debidanga, Champasari, near Uday Sporting Club, PS- Pradhan Nagar, Dist. Darjeeling, at around 18.45 hrs I received source information that one above named accused person has stored huge quantity of illicit liquor and selling the same illegally in his own residence, at Debidanga near Uday spoorting club without any valid documents. Accordingly I diarized the information in PS General Diary vide Pradhannagar Police Station GDE No. 1244 dated 21.11.2025 and I informed the matter to you over phone.

As per your kind order and direction, I along with, ASI Prabal Sarkar along with force all of Pradhan Nagar PS left for Debidanga under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. On arriving at Debidanga, I contacted with my source and as identified by him, I along with other officers and force entered into the residence of said Sandhu @ Sanu Parti (41yrs) S/O Manshingh Parti, of Debidanga, Champasari, near Uday Sporting Club, PS- Pradhan Nagar, Dist. Darjeeling and conducted a raid and managed to detain him. On interrogation he disclosed his identity as noted above. On further interrogotation he disclosed that he is selling and store liquor at the house without any valid documents, for his wrongful gain. On search the above noted illicit liquor was recovered from his house. On demand he failed to produce any valid documents or licence to possessising/storing such illicit liquor at his house. As he willfully violated the norms of Bengal Excise Act hence, I seized the above noted illegal liqior from his possession under proper seizure list in presence of available independent witnesses. The entire process of search and seizure was made in between 19:30 hrs to 20:05 hrs under the coverage of videography. Subsequently, I arrested the above noted detained person namely Sandhu @ Sanu Parti (41yrs) S/O Manshingh Parti, of Debidanga, Champasari, near Uday Sporting Club, PS- Pradhan Nagar, Dist. Darjeeling after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Sandhu @ Sanu Parti (41yrs) S/O Manshingh Parti, of Debidanga, Champasari, near Uday Sporting Club, PS- Pradhan Nagar, Dist. Darjeeling, for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.
