Sir,

In producing herewith 04 (four) following accused persons namely (i) Prakash Darjee (35 yrs) S/O Late Dilip Darjee of Champasari Kali Mandir, Ward No-46, PS- Pradhan Nagar, Dist. Darjeeling (ii) Prakash Mahato @ Banta (19 yrs) S/O Late Maneswar Mahato of Gurung Busty, Ward No-03, PS- Pradhan Nagar, Dist. Darjeeling (iii) Manu Kamti (21 yrs) S/O Kari Kamti of Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and (iv) Biplab Roy (23 yrs) S/O Late Nirmal Roy of Diesel Colony, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :- (i) One sharp cutting iron made weapon locally called as "Hasua" measuring approx 25 inches in length including its wooden butt (ii) One sharp cutting iron made weapon locally called as "Khukuri" measuring approx 23 inches in length including its wooden butt (iii) one house breaking instrument locally called as "Sabal" measuring approx 24 inches in length (iv) one iron made Haksaw blade measuring approx 24 inches in length including its wooden butt, (v) one iron made hammer including its wooden butt measuring approx 8 inches in length (vi) one Plus measuring approx 7 inches and (viii) one multi colour nylon bag. I, ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted four (04) arrested accused persons and others 07/08 unknown miscreants who involve in this crime, to the effect that on 21.11.25 at 21.25 hrs I received a specific source information that about 11/12 miscreants equipped with deadly weapons assembled at Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparation for committing Dacoity at Himachal Colony and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 1256 dated 21.11.2025 and informed the matter to you. As per your kind order and direction, I along with SI Rajiv Subba, ASI Biplab Kr Das, ASI Bikash Roy and force all of Pradhan Nagar PS, SPC left for Himachal Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed night RT van officer SI Tinku Modak and requested him to come to Himachal Colony to accompany us. At around 21.40 hrs we arrived at Himachal Colony under PS- Pradhan Nagar, Dist. Darjeeling and after a while night RT van officer SI Tinku Modal and force arrived at the spot to accompany us. I shared the information with my raid team and briefed them properly. Then, I contacted my source and from a considerable distance he pointed the place where the miscreants were assembled. Then, I requested two available independent witnesses namely (i) Binay Mandal (51 yrs) S/O Late Ramchandra Mandal of Siliguri Junction, Ward No-01, PS- Pradhan Naggar, Dist. Darjeeling and (ii) Krishna Dusad (49 yrs) S/O Late Nayayan Dusad of Siliguri Junction, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance we noticed that 11/12 persons were assembled in a vacate land at Himachal Colony Under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehended above named four (04) accused persons while 07/08 others unknown miscreants managed to flee away taking the advantage of open place and darkness. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multi color nylon bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such an open place. Finally they disclosed that they along with 07/08 of their associates assembled there and were making preparations for committing Dacoity at Himachal Colony and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 22.05 hrs. to 22.45 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest and also provided them written information regarding ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS through E-Sakhya Apps and brought all four (04) arrested accused persons along with seized articles to Pradhan Nagar P.S for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with 07/08 of their associates who fled away, gathered there equipped with deadly weapons and taking preparation to commit Dacoity in a nearby affluent area at Himachal Colony.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted four (04) arrested accused persons namely (i) Prakash Darjee (35 yrs) S/O Late Dilip Darjee of Champasari Kali Mandir, Ward No-46, PS- Pradhan Nagar, Dist. Darjeeling (ii) Prakash Mahato @ Banta (19 yrs) S/O Late Maneswar Mahato of Gurung Busty, Ward No-03, PS- Pradhan Nagar, Dist. Darjeeling (iii) Manu Kamti (21 yrs) S/O Kari Kamti of Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling and (iv) Biplab Roy (23 yrs) S/O Late Nirmal Roy of Diesel Colony, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and others 07/08 unknown miscreants who fled away from the spot and arranged for its investigation.
