Sir

In producing herewith 01 (one) accused person namely Sagar Mangar (27 yrs) S/O Late Bijay Mangar of Chandraloke, near SIB Office, PS+Dist.- Kalimpong under arrest and the following articles under seizure viz (i) 01 (one) Automatic Fire Arms (PISTAL) measuring 22 cm in length marked as 'AUTOMATIC PISTAL, MADE IN U.S.A. NO -7317' having pistol grip, barrel, slide, ejection slot, hammer, trigger, trigger guard and Magazine in proper working condition - Marked as Exhibit "A" and (ii) 02 (two) round of live ammunitions- Marked as Exhibit - 'B'. I, SI Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Sagar Mangar (27 yrs) S/O Late Bijay Mangar of Chandraloke, near SIB Office, PS+Dist.- Kalimpong to the effect that on 21.11.2025 at 22.35 hrs I received a specific secret source information that one person possessing illegal fire arms and ammunition is moving at near SNT, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling with a view to sell the same to his designed customers or to commit any heinous crime at the locality. Accordingly, I diarized the information in P.S. General Diary vide Pradhan Nagar PS GDE No. 1268 dated 21.11.2025 and informed the fact to you, and as per your kind order and direction myself along with ASI Biplab Kr Das, ASI Bikash Roy and force left for SNT, Siliguri Junction under P.S- Pradhan Nagar, Dist. Darjeeling with an investigation kit to work out the information in hand by Govt. vehicle vide Pradhan Nagar PS MCC No 1323/25 dated 21.11.25. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. On the way, I requested night RT Van officer SI Tinku Modak to SNT, Siliguri Junction to accompany us and also informed one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling over telephone and requested him to come to Siliguri Junction under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graphs if required.

At around 22:45 hrs we arrived Siliguri Junction near SNT and at around 22.55 hrs RT Van officer SI Tinku Modak and his van force arrived there and accompanied us. I shared the information with them and briefed them properly. Thereafter, I requested two independent persons namely (i) Bittu Singh (26 yrs) S/O Uday Singh of South Ambedkar Colony, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 6294808546) and (ii) Arun Sahani (25 yrs) S/O Upendar Sahani of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 9339932433) and shared the information with them and requested to remain present and act as witness during search and seizure if required upon which they agreed. Then, I contacted with my source and he informed me that the suspect is seating at Namchi Taxi Stand near SNT, Siliguri Junction. There after from a considerable distance we noticed that one person is seating at Namchi Taxi Stand near SNT, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling. Then, we cordoned the place from every corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we were able to apprehend him. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. As per source information that he is possessing firearms and ammunition hence immediately, I searched the said detained person and recovered the following articles viz :- (i) 01 (one) Automatic Fire Arms (PISTAL) measuring 22 cm in length marked as 'AUTOMATIC PISTAL, MADE IN U.S.A. NO -7317' having pistol grip, barrel, slide, ejection slot, hammer, trigger, trigger guard and Magazine in proper working condition and (ii) 02 (two) round of live ammunitions from his possession. On demand he failed to produce any document in respect of fire Arm and ammunition which was recovered from his exclusive and conscious possession. Accordingly, I seized the above-mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledged by the accused person. The search seizure and label were made under the coverage of videography executed by Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling as per norms of BNSS in between 23.15 hrs to 23.40 hrs on 21.11.25 at the spot. On further interrogation he admitted his guilt and disclosed that he came there to deliver the said fire arms and ammunition to his design customer for his wrongful gain.


Thus, when his involvement in carrying and possessing illegal Firearms and ammunition was established, accordingly I arrested him under proper memo of arrest and observed all the formalities for violating the norms of Arms Act. I informed him regarding grounds of arrest and also issued a copy of memo of arrest and ground of arrest to him.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Sagar Mangar (27 yrs) S/O Late Bijay Mangar of Chandraloke, near SIB Office, PS+Dist.- Kalimpong is desperate and dangerous in nature, as he was carrying the said Fire arm and 02 (two) rounds of live ammunition with an objective to sell the same or to commit any heinous crime in the locality. As he wilfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Sagar Mangar (27 yrs) S/O Late Bijay Mangar of Chandraloke, near SIB Office, PS+Dist.- Kalimpong under proper section of law and may arrange to cause its investigation.


