Sir, In producing herewith one female accused person namely- Chandana Routh (55 yrs/Female) W/O Late Ram Chandra Routh of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri Dist- Darjeeling along with the following seized articles as per proper seizure list:

1. 20 (Twenty ) sealed Bottles of " Dil Se "country spirit 80 UP each bottle containing 600 Ml each , amounting of Rs.60/- each,

I, ASI Rabin Lama of Siliguri PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 21.11.24 at 13.55 hrs received a source information that one person namely Chandana Routh of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri Dist- Darjeeling was selling at her shop situated at Tikiapara Sabji Market under Siliguri PS with huge amount of liquor illegally for her wrongful gain. This refers to Siliguri PS GDE no- 937 dated 21.11.24. I informed to I/C Siliguri PS about the above mentioned information. As per order of I/C Siliguri PS, I along with ASI Subir Sen and C/160 Soumen Sarkar proceeded to Tikiapara Sabji Market under Siliguri PS to work out the information vide Siliguri PS GDE No. 942 dated 21.11.25. At 14.25 hrs we reached at the spot, being identified by the source our police party found that the above noted mentioned person was busy to sell liquor to her design customer. On seeing the police party all consumed persons managed to flew away but we managed to apprehend the above noted person. On being asked she disclosed her identity as noted above. On searched the above noted seized articles as per seizure memo was found from her possession. On searched interrogation she failed to produce any valid documents in respect of above noted mentioned seized articles. On further interrogation she became nervous and admitted her guilt before us and stated that she sold the same to her design customers since long for her wrongful gain. In presence of witnesses namely 1. Smt Mala Sarkar (21 yrs) W/O Late Tarak Das of Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling, 2. Shiv Kumar Paswan S/O Sonelal Paswan of Tikiapara, Matangini-II, PS-Siliguri, Dist- Darjeeling , I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and label and took signature of the accused person as well as witnesses duly signed by them. The seizure was made between 14.35 hrs to 15.25 hrs. I arrested the said person u/s 35(1) of BNSS after issuing a Memo of arrest appraising the ground of arrest in presence of witnesses with the help of lady force as she violated the norms of Bengal Excise Act. The whole seizure process was recorded under Audio and Videography.


I therefore request you a specific case may kindly be started against the accused person namely Chandana Routh (55 yrs/Female) W/O Late Ram Chandra Routh of Tikiapara, Matangini-II, Ward No. 28, PS- Siliguri Dist- Darjeeling under proper section of law.
