Sir,
In producing herewith one arrested accused person namely Ranjit Mallick (M/58 yrs), S/O - Lt. Mahabir Mallick of Mahakalpally, W/No. 10, PS- Siliguri, Dist - Darjeeling along with seized articles (1) 10 (Ten) sealed Bottles of Himalayan Gold Country Spirit each bottle containing 600 ml. each (2) 01 (One) Nylon Bag which was used for carrying the seized articles SL. N- 1. I, SI. Prakash Ch. Sarkar of Panitanki TOP under Siliguri PS hereby lodge this written complaint against the above noted accused person to the effect that on 21.11.2025 at 19.05 hrs received secret source information that one person is carrying huge quantity of country spirit bottle through Bidhan Road and approaching towards Panitanki More. Accordingly informed the same to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 481, dated 21.11.2025 and thereafter as per his direction I along with, PSI Sujit Mandal, C/233 Nagen Ch. Barman and C/702 Latifur Rahaman left from Panitanki TOP to work out the veracity of information. On arrival near Shree Ram Lodge, Bidhan Road, Siliguri at 19.15 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit carrying in a Nylon bag. Accordingly I have intercepted & apprehended him. Then I searched him in presence of two independent witnesses named (i) Rakesh Kurmi S/O- Lt. Ramesh Kurmi of Bidhan Road, Ps-Siliguri, Dist-Darjeeling & (ii) Jayanta Roy S/O Biky Roy of Bidhan Road, Ps-Siliguri, Dist-Darjeeling and recovered 10 (Ten) sealed Bottles of Himalayan Gold Country Spirit each bottle containing 600 ml. each. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sell the same illegally to the local public of Mahakalpally and adjacent areas for his wrongful gain and livelihood. Accordingly I seized the (i) 10 (Ten) sealed Bottles of Himalayan Gold Country Spirit each bottle containing 600 ml. each (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made in between 19.20 hrs and 19.35 hrs. I then arrested the accused person u/s 35 BNSS after explaining charges against him.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person Ranjit Mallick (M/58 yrs), S/O - Lt. Mahabir Mallick of Mahakalpally, W/No. 10, PS- Siliguri, Dist - Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
