In producing herewith arrested accused namely (i) Bana Sarkar (52 yrs/M) S/o- Lt. Swarup Sarkar of Balarampara, PS- Bhorer Alo, Dist- Jalpaiguri arrested u/s- 35(1) BNSS along with following seized articles viz: i) Eleven (11) Bottles Sealed 70 UP "OYE OYE" each bottle containing 300 MI labeled as GALAXY C.S. BOTTLING PLANT NAGRAKATA, JALPAIGURI, West Bengal @ Rs 40/- each (Amounting of Rs. 40/- X 11=Rs 440/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.

I, PSI Wahed Kamal Pramanik of Bhorer Alo PS, SPC do hereby lodge this written complaint against the accused person namely Bana Sarkar S/o- Lt. Swarup Sarkar of Balarampara, PS- Bhorer Alo, Dist- Jalpaiguri to the effect that on 21.11.25 at 19:05 hrs onwards during my Special raid duty, as per source information when we reached at Balarampara at the house of Bana Sarkar and found huge quantity of illicit liquor in his house. Accordingly we apprehended him and on interrogation he stated that the above noted illicit liquor he gathered to sell the same at Farabari area under Bhorer Alo PS area.

On further interrogation he stated that he used to sale the 70 UP OYE OYE to the customers at different areas without any valid documents, as he violated the norms of Bengal Excise Act for selling the said liquor without any valid license. On search found Eleven (11) Bottles Sealed 70 UP "OYE OYE" each bottle containing 300 MI labeled as GALAXY C.S. BOTTLING PLANT NAGRAKATA, JALPAIGURI, West Bengal @ Rs 40/- each (Amounting of Rs. 40/- X 11=Rs 440/-) in which one sealed bottle has taken from mother packet as sample as per seizure list. On being interrogation he could not produce any valid documents in respect of said illicit liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Then I seized and labeled the above mentioned articles under proper seizure list in presence of witnesses and subsequently arrested the above mentioned person namely Bana sarkar after observing all the formalities. The whole process of seizure and label has been made in between 19:52 hrs to 19:58 hrs.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused namely Bana Sarkar S/o- Lt. Swarup Sarkar of Balarampara, PS- Bhorer Alo, Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigation.
