With due respect, I am producing herewith 01 (one) arrested lady accused person, namely Sushma Singh (40 yrs), W/O- Ajay Singh, D/O- Lt. Ram Dayal Singh of Khaprail Sainikpuri near Haria More, PO- New Chumta, PS- Matigara, Dist- Darjeeling and the following seized articles:

- 1] Four (04) bottle of BUDWEISER MAGNUM beer each bottle contain 650 ml and from which one bottle taken as sample and marked as 'Exhibit- A'.
  - 2] Two (02) bottle of BLENDERS PRIDE ultra premium whisky each bottle containing 750 ml and from which one bottle taken as sample and marked as 'Exhibit- B'.
  - 3] One bottle SIGNATURE Premier Grain Whisky containing 750 ml and marked as 'Exhibit- C'.
  - 4] One bottle ROYAL STAG Superior Whisky containing 750 ml and marked as 'Exhibit- D'.
- in total 5.6 Liter. The ground of arrest duly been communicated with her.

I, ASI Chandra Prakash Adhikari, of Matigara PS, SPC under your kind control beg to state that on 21.11.2025 at around 13:20 hrs I received a secret source information that one lady as noted above is selling liquor illegally from her shop styled as Pardeshi Restaurant located at Tarunjabari near Fulbari Patan bridge, PO- New Chumta, PS- Matigara, Dist- Darjeeling. Accordingly informed to I/C PS and as per his kind direction myself along with L/C 1286 Anisha Chhetri, C/523 Sanjit Kundu and C/868 Sujal Roy all are of Matigara PS, SPC left for near Fulbari Patan bridge under Matigara PS to work out the information in hand. This refers to MTG PS GDE No. 1146, Dt- 21.11.2025. At 13:40 hrs we arrived at the restaurant near Fulbari Patan bridge and I detained the above noted lady person in red hand with the help of lady police constable who has stored liquor at her restaurant for selling. On being asked she disclosed her name and address as noted above. During interrogation she disclosed that she is selling liquor from her restaurant located at Tarunjabari near Fulbari Patan bridge, PO- New Chumta, PS- Matigara, Dist- Darjeeling for her illegal gain. On being search the restaurant, the above noted liquor were recovered. On demand she failed to produce any documents/license in respect of store/sale of the liquor which were recovered from her restaurant. Accordingly, I seized the above noted liquor which were found from her possession under proper seizure list and arrested her under proper memo of arrest and observing all the formalities in presence of L/C 1286 Anisha Chhetri. The whole process of search, seizure, label & arrest was made in between 13:45 hrs to 14:20 hrs on 21.11.2025 under videography. The video was done by C/523 Sanjit Kundu.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested lady accused namely Sushma Singh (40 yrs), W/O- Ajay Singh, D/O- Lt. Ram Dayal Singh of Khaprail Sainikpuri near Haria More, PO- New Chumta, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
