Sub: - Complaint

Sir,

With due respect and humble submission I, ASI Dipak Karmakar S/o Lt. Dulal Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against one Jiban Rai (50 yrs) S/o Lt. Dhan Bahadur Rai of Demdema Busty, Near Health Centre, PS-Bhaktinagar, Dist Jalpaiguri to the effect that on 19/11/25 at 13.55 hrs received a source information that one Jiban Rai (50 yrs) S/o Lt. Dhan Bahadur Rai of Demdema Busty, Near Health Centre, PS-Bhaktinagar, Dist Jalpaiguri has gathered huge quantity of liquor in his grocery shop for selling the same for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-891 dated 19/11/25. As per your kind instruction immediately myself along with ASI Dhurbo Misra, ASI Khagen Barman and C/374 Debraj Biswas proceeded to the PO to work out the information, within 30 minutes we reached at the spot, sometimes after, being identified by the source our police party held raid and seeing the Police party the above noted person fled away from his shop. On hot chase by police personal failed to arrest him but recovered and seized the following articles from his grocery shop at Demdema Busty under Bhaktinagar PS:-

(1) 11 (Eleven) bottles of Kingfisher strong beer (each bottle containing 650 ML)

During local enquiry it came to learn that the name of alleged person is Jiban Rai (50 yrs) S/o Lt. Dhan Bahadur Rai of Demdema Busty, Near Health Centre, PS-Bhaktinagar, Dist Jalpaiguri. He is selling the same in open village since long for his wrongful gain without any valid documents/license. In presence of witnesses namely (1) Fajjul Rahaman (24 yrs) S/o Aliyar Rahaman, Demdema Busty, Near Health Centre, PS Bhaktinaga, Dist Jalpaiguri (2) Kajol Roy S/o Lt. Ranjit Roy of Demdema Busty, Near Health Centre, PS Bhaktinagar, Dist Jalpaiguri, I seized the above noted articles from the PO (The seizure was made in between 14.40 hrs to 15.10 hrs) after preparing proper seizure list duly signed by them. The whole search and seizure process was conducted under proper audio video record.

I therefore request you a specific case may kindly be started against the accused Jiban Rai (50 yrs) S/o Lt. Dhan Bahadur Rai of Demdema Busty, Near Health Centre, PS-Bhaktinagar, Dist Jalpaiguri under proper section of law and arrange for investigation..
