In producing herewith following three arrested accused persons, namely (1) Samar Das-32yrs s/o Lt Subhash Das of 2 No Jyotinagar, Ranjit More ward no-40 PS Bhaktinagar Dist Jalpaiguri (2) Nipul Sikdar-46yrs s/o Dhiren Sikdar of Asrafnagar, Maszid road, ward no-40 PS Bhaktinagar Dist Jalpaiguri and (2) Sanjay @ Hodol Rajbanshi-24yrs s/o Chimanta Rajbanshi of Dakshin Palash, PO Champasari PS Pradhannagar Dist Darjeeling along with following seized articles viz:

- 1) One iron made hummer having length approx. 11 inches recovered from the exclusive and Conscious possession of Samar Das.
- 2) One iron made screwdriver with plastic butt having length approx 11 inches recovered from the exclusive and Conscious possession of Nipul Sikdar.
- 3) One iron made plus (tools) with having length approx. 08 inches recovered from the exclusive and Conscious possession of Sanjay @ Hodol Rajbanshi.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 10/11 others to the effect that on 21.11.2025 at 00:05 hrs received a specific source information that 12/13 miscreants have assembled at P.C Mittal bus stand, near Tower under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No =1019 dated 21.11.2025 and as per order I along with SI Srimanta Chatterjee, SI Yuel Lepcha, ASI Khagen Barman C/374 Debraj Biswas, C/1431 Dilip Barman all of Bhaktinagar, PS, SPC, left for P.C Mittal bus stand, near Tower under Bhaktinagar PS to work out the information in hand. This refers to Bhaktinagar PS GDE No- 1020 dated 21.11.25.

At about 00.15 hrs we arrived at P.C Mittal bus stand, near Tower under Bhaktinagar PS as indicated by the source we noticed that 12/13 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 03(three) of them with deadly weapons in their possession but 9/10 persons managed to fled away from the spot taking the advantage of darkness and open place. One Sanjay, Takla, Suman and others also fled away from the spot.

On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and

making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.


Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 21.11.2025 in between 00.20hrs to 01.05hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons namely (1) Samar Das-32yrs s/o Lt Subhash Das of 2 No Jyotinagar, Ranjit More ward no-40 PS Bhaktinagar Dist Jalpaiguri (2) Nipul Sikdar-46yrs s/o Dhiren Sikdar of Asrafnagar, Maszid road, ward no-40 PS Bhaktinagar Dist Jalpaiguri and (2) Sanjay @ Hodol Rajbanshi-24yrs s/o Chimanta Rajbanshi of Dakshin Palash, PO Champasari PS Pradhannagar Dist Darjeeling and others kindly arrange for its investigation.
