Sir,

This is to bring to your kind attention that, today i.e on 22.11.2025 at around 11:55am, we received information that an electrical accident occurred at Gurung Basti (opp. Buddha Mandir), beside Shree Ram Bharat Enclave.

Mobile van of Pradhannagar CCC visited the site and found that a person has received electric shock while stealing the flexible chord from a Double Rail Pole structure.

The person has been identified as Mithun Shil, S/O-Ranjan Shil, Address-Uttar Bharat Nagar, Shramik Nagar.

This person seems to be a regular offender as an FIR against him had already been lodged by the Station Manager, Milanpally CCC on 29.10.2025 at Siliguri Police Station (copy of the FIR attached herewith).

The site was visited by the U/S alongwith Debanjan Datta, S/O-Ramendranath Datta, AE(Tech)-9332789035, Siliguri Town Division, WBSEDCL and found that the following materials have been stolen resulting in monetary loss to WBSEDCL.

- 1) Quantity of material stolen : Flexible Chord-2 nos
- 2) Cost Of Materials : Rs. 766/- (Approx.)(Rs.383/unit)

Local people were asked to give their written statement but none appeared.

Hence, you are requested to register an FIR against Mithun Shil, S/O-Ranjan Shil, for theft of materials of electrical infrastructure of WBSEDCL U/S 136 1(a) of Electricity Act 2003
