Sir,

In producing herewith one arrested person namely Dinabandhu Barman (26 years) S/O Parmananda Barman of Pani Tanki, hari Busty, near SSK School, PO Dulaljote, PS Khoribari, Dist Darjeeling along with the following seized articles under seizure as per seizure list:

- 1) One transparent plastic containing 721 grams said to be Brown Sugar which is marked as Exhibit "A".
- 2) One transparent plastic containing 832 grams said to be Brown Sugar which is marked as Exhibit "B".
- 3) One black colour Back pack style as "LIBYA SAVE LIFE" which is marked as Exhibit "C".
- 4) One Blue colour Realme mobile phone having IMEI no 866608078785378, Connecting no 9046813837 / 7557042415.
- 5) One Blue & Orange mixed Colour Duke 390 motorcycle having registration no WB 73 P 3319.

Note: Exhibit A & B are kept in exhibit "C". In total 1553 grams said to Brown Sugar.

I, SI Youel Lepcha, S/O Jai Tshering Lepcha, of Bhaktinagar PS under Siliguri Police Commissionerate, hereby submit this written complaint against the above-mentioned accused person. On 22.11.2025, at about 18.05 hours, I received reliable information indicating that an individual coming from Naxalbari Side on a duke motor cycle having number WB 73 P 3319 who is believed to be in possession of a Narcotic substance.

This information was recorded in the Bhaktinagar PS diary as GDE No. 1115/25 dated 22.11.2025. Following this, I informed the matter in writing to the In-Charge of Bhaktinagar PS. Upon receiving directives, at around 18.15 hours, I, along with SI Srimanta Chatterjee, ASI Dhurbo Mishra, ASI Dipak Karmakar, ASI Khagen Barman and Constable 374 Debraj Biswas, departed from the police station in a government-hired vehicle to verify the validity of the information. This refers to Bhaktinagar PS GDE no. 1116/25 dated 22.11.2025 and M.C.C No- 5609/25 dated 22.11.2025.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

As per the order of the In-Charge of the Police Station, I called K 37 ASI Sadan Kr Roy, C/1427 Swapan Roy, and C/1426 Prasanta Kumar Dutta to accompany us in pursuing this information. At approximately 18:35 hours, we arrived at National Highway 10 in front of Indira Gandhi Maidan under Bhaktinagar PS and began naka checking.

Once there, I convinced the available public who were present at that time, following two persons came forward to accompany us for conducting search & Seizure if required, the details of individuals are 1) Shaswat Choudhary (21 years) S/O Ranjit Choudhary of Gandhi Nagar, near Holy Crown School, ward no 43, PS Bhaktinagar, Dist Jalpaiguri. 2) Tarvej Alam (25 years) S/O Lt Abdul Rajaq of Gandhi nagar near Milton School, ward no 43, PS Bhaktinagar, Dist Jalpaiguri.

After that, I informed them about the available information and requested, in writing, that they accompany us throughout the process of any search and seizure. They provided written approval to join the police during the raid, search, and seizure. Acting on a tip-off, at about 17.40hrs, we detained a blue Duke motorcycle with the registration number WB 73 P 3319. The motorcycle was being driven by an individual carrying a black backpack. We identified ourselves and provided the information we had, explaining that the individual would be searched. He disclosed his name and address as noted above.

He admitted that he was in possession of brown sugar, intending to supply it to his designated customers as needed. I then offered him the option to be searched in the presence of a Special Executive Magistrate or by a Gazetted Officer. He agreed to be searched by one of them. Subsequently, I issued a notice in accordance with legal provisions regarding the matter. I sent a written requisition to Shri Kajal Sarkar, Inspector In-Charge of Bhaktinagar Police Station, requesting him to come at National Highway 10, in front of Gandhi Maidan under the jurisdiction of Bhaktinagar PS to supervise a search and seizure operation.

At 20.15 hours, Shri Kajal Sarkar arrived at the location as the Gazetted Police Officer. Subsequently, under his supervision and in the presence of witnesses, Upon conducting a thorough search of the detained individual and back pack which was carried by him and his motorcycle, I found the mentioned article i.e. black colour back pack style as "LIBYA SAVE LIFE" contains with above noted articles.

Further being demanded in presence of Shri Kajal Sarkar Inspector In-Charge, Gazette Police Officer the detained person failed to produce any valid document in support of aforesaid recovered brown sugar.

I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses, I also labeled and sealed the same, the entire search and Seizure was conducted under the supervision of Shri Kajal Sarkar, Inspector In-Charge of Bhaktinagar PS. The whole process of search & seizure has been captured in audio & video records. The whole process of seizure was made on 22.11.2025 between 20.25 hrs to 21.35hrs

Being further asked, the apprehend person admitted in presence of Shri Kajal Sarkar, Inspector In-Charge of Bhaktinagar PS and other witnesses that he procured the brown sugar clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for personal gain by illegal means also disclosed that he has been dealing in such business of procuring and selling of brown sugar illegally for last few months.

Then, I arrested the above noted accused person namely Dinabandhu Barman (26 years) S/O Parmananda Barman of Pani Tanki, hari Busty, near SSK School, PO Dulaljote, PS Khoribari, Dist Darjeeling, after observing all formalities and informing the ground of his arrest and issued a necessary Memo of Arrest u/s 35 of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Dinabandhu Barman (26 years) S/O Parmananda Barman of Pani Tanki, hari Busty, near SSK School, PO Dulaljote, PS Khoribari, Dist Darjeeling and arrange for its investigation.
