Sir,

Most respectfully and humble submission I SI Pintu Ghosh of Bhaktinagar Police Station beg to inform you that last night i.e. 21/22-11-2025 I along with Const.380 Paresh Kisku and const. 1413 Dilip Barman all of Bhaktinagar PS were detailed for performing K-37 van patrolling duty under Bhaktinagar PS area vide MCC No 5599 /25 Dtd. 22/11/25 . During patrolling duty at about 01:35 Hrs received an information from duty officer that an accident occurred at 8th mile on NH 10 near forest area between two vehicles . Accordingly without laps of time I along with above mentioned force left for 8th mile to verify the veracity of the information. At about 01:55 Hrs we arrived at the spot i.e. 8th mile and found an accident occurred between one TATA Winger vehicle displaying registration No SK 04J 1248 and one truck loaded with bricks displaying registration no WB 73 G 6458 and also hearing that some passengers were received grievous injuries on their persons who were shifted to Siliguri District Hospital and Anandoloke Hospital respectively by the available local people for their treatment.

I ,therefore request you a specific case may kindly be recorded as per proper section of law .
