Respected Sir,

With due respect, I ASI Tapan Roy s/o Sri Fanindra Nath Roy posted at Ashighar Out Post under Bhaktinagar P.S, SPC do hereby lodge this written complaint against the 40/50 unknown miscreant persons all are inhabitant of South Shantinagar under PS, Bhaktinagar Dist, Jalpaiguri

The brief fact is that on 22.11.25 from 14.00 hrs to 22.00 hrs in course of evening mobile van duty under Ashighar OP, areas vide GDE NO 690 dtd, 22.11.25. in course of van duty at around 15.45 hrs received control information that one person commit suicide at South Shantinagar. Accordingly the matter was diarized vide Ashighar OP, GDE No...694 dtd, 22.11.25 and as per kind direction, I along with force immediate rushed at the spot to verify the information. After arrived the spot I came to noticed that 40/45 local people gathered in front of the house of Subash Das s/o Late Khagen Das of Dakshin Shantinagar BInoy More under PS, Bhaktinagar and came to know that one Sanjay Das aged approx 25 yrs s/o Subash Das commit suicide at his bed room by hanging around 14.00 hrs to 14.30 hrs. During preliminary enquiry while I was busy to dispatch the dead body of deceased before SDH Siliguri at that time some unknown people badly manhandled by the following person ie i) Sampa Roy Das 22yrs ii) Sunil Roy 40 yrs iii) Smt Bholu Roy and iv) Bhaskar Roy and tried to create a law & order situation over this issues. Accordingly, the dead body of deceased has been sends to the Siliguri District Hospital, and rescued the above noted manhandled four persons from the spot and then produced them before the SDH Siliguri and obtaining their medical treatment. After that, I brought them at Bhaktinagar PS, for their safe custody. At around 19.05 hrs one Subash Das came at OP, and lodge a written complaint that his son commit suicide due to the torture and mental presser of his son wife and others in laws. Over his complaint Bhaktinagar PS, case no 1139/25 dtd, 22.11.25 u/s 108/3(5) BNS 2023.

Under the above-noted facts and circumstances, I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against the 40/50 unknown miscreant persons all are inhabitant of South Shantinagar under PS, Bhaktinagar Dist, Jalpaiguri, and request to arrange its investigation.
