with due respect I am Puja sah W/O Binod sah resident of Darjeeling more Sabji Bazar, near Assam rail gate, Siliguri, Darjeeling, West Bengal. would like to inform you that on 22/11/25 at arround 7 pm one person namely (Subodh thakur along with, manoj singh, and Sangita thakur) entered into my house without permission and assault me and husband.

on 22/11/25 at arround 7 pm the above mentioned person entered into my house forcefully without any reason and approached towards my husband, by seeing that my husband asked them that why they entered into my house, by asking them they suddenly grabbed the collar and started assaulting my husband with bones and fist, punch and also with helmet, by seeing the conflict, I immediately approached them to save my husband from their hands, but they also assault me, with helmet, punch and also push me towards the wall, with the intentions to hurt me, and also tried to tear my cloths, but somehow I saved myself and my husband from their hand with help of my mother in law after they threatened us to kill wherever they get the chance and also told that they will come again to assault us and flew away. I also have two children and I am in a great fear after of the incident.

Hence I pray before you that you may consider my prayer and take a necessary action against them and obliged.
