Sir,

In producing herewith the accused person named Upendar Prasad (33 years), S/O Surendar Prasad of Mandir Line MW, Singtham, PS Gangtok, East Sikkim; presently residing at Saman Nagar, under PS Pradhan Nagar, Dist. Darjeeling, who has been arrested, along with the following seized articles under a proper seizure list viz :- (i) Thirty six (36) bottles of Old Monk XXX Delux Rum, each bottle containing 750 ml, i.e. total 36 x 750 ml = 27 liters, marked as Exhibit "A" found inside the two broom sacks, out of which one bottle of the same taken as sample for examination and marked as Exhibit "A-1".

On 23.11.2025 at around 15:25 hrs, I received specific secret information that one person carrying a huge quantity of illicit liquor in broom sacks without any valid licence was standing at Siliguri Junction, Raj Bus Counter, waiting for a Bihar-bound bus. Accordingly, I diarised the information in the PS General Diary vide Pradhan Nagar PS GDE No. 1357 dated 23.11.2025, and informed you over phone.

As per your kind order and direction, I, along with ASI Bikash Roy and force of Pradhan Nagar PS, proceeded to Siliguri Junction, Raj Bus Counter in a Government vehicle with the investigation kit. I briefed all personnel regarding the information and briefed them properly. Upon arrival, I contacted my source, and as identified by him, we apprehended one person. On questioning, he disclosed his identity as stated above. He was carrying two jute sacks containing brooms. On searching the sacks, we recovered the above-noted illicit liquor concealed inside the brooms. On demand, he failed to produce any valid licence or documents for possessing or transporting such liquor. Upon further interrogation, he disclosed that he illegally procured the liquor from Siliguri and was waiting for a Bihar-bound bus with the intention of selling it in Bihar at a higher price for illegal profit. He admitted that he has been involved in such activities for a long time. His actions clearly violate the provisions of the West Bengal Excise Act. Accordingly, the illicit liquor was seized under a proper seizure list in presence of independent witnesses from the possession of Upendar Prasad (33 years), S/O Surendar Prasad of Mandir Line MW, Singtham, PS Gangtok, East Sikkim; presently residing at Saman Nagar, under PS Pradhan Nagar, Dist. Darjeeling. The entire process of search and seizure was conducted between 16:40 hrs to 17:15 hrs, under videography coverage. Subsequently, I arrested the accused Upendar Prasad, observing all legal formalities and informed him of the grounds of arrest for violating the provisions of the West Bengal Excise Act. His wife named Priyanka Devi was also informed over telephone about his arrest.

Under the above noted fact and circumstances I pray before you that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Upendar Prasad (33), S/O Surendar Prasad of Mandir line MW, Singtham, PS. Gangtok, East Sikkim, A/P Saman Nagar, PS- Pradhan Nagar, Dist. Darjeeling, for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.
