Sir,

I Sri Debanjan Datta, S/o- Sri Ramendra Nath Datta, age 30 years, posted as Assistant Engineer (E) at Siliguri Town Division, WSEDCL would like to inform you that on 23.11.2025 at 11:01 AM, IOCL 11 kV Feeder emanating from Deshbandhupara 33/11 kV Sub-Station under Siliguri Town Division, WSEDCL was reported "breakdown" from Sub-Station end. On subsequent line patrolling of the 11 kV IOCL Feeder by HT Mobile Van of Deshbandhupara Sub-Station, it was learnt that an 8M HTOH PCC Pole near BPCL Plant was damaged by a vehicle, whose Reg. No. couldn't be traced by us.

Due to this accident caused by the unknown vehicle, HTOH infrastructure of WSEDCL has been damaged and unplanned power interruption has been caused and the pole will have to be replaced by WSEDCL on safety grounds. On account of this accident, WSEDCL has to bear a total cost of Rs. 34,436/- approximately as network restoration charges.

Therefore you are requested to lodge the complaint & take necessary accordingly.
