In producing herewith the female accused person named Lata Lohar, aged 35 years, w/o-Laxman Lohar, resident of Putimari, near Kalimandir Math, PS- Bagdogra, Dist- Darjeeling (Aadhar No. 2523 0855 8099) under custody along with following seized articles under proper seizure list:

1. Four (04) bottles of "Himalayan Gold 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/-; out of which 01 bottle is taken out as sample and marked as Exhibit- A.
2. Five (05) ltrs of Chullu in one green colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- B.
3. Five (05) ltrs of Chullu in one green colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- C.
4. Five (05) ltrs of Chullu in one green colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- D.
5. Five (05) ltrs of Chullu in one green colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- E.
6. Five (05) ltrs of Chullu in one blue colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- F.

I, ASI Amit Lama of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested female accused person named Lata Lohar, aged 35 years, w/o-Laxman Lohar, resident of Putimari, near Kalimandir Math, PS- Bagdogra, Dist- Darjeeling to the effect that on 21.11.2025 at 12:15 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect named Lata Lohar located at Putimari, near Kalimandir Math under Bagdogra PS and the same has been selling illegally from that house cum shop for her wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with SI Binup Mahato, SI Debabrata Kundu, LCV/1025 Anila Singha, LCV/211 Jayanti Barman, VP/01 Anselam Kujur, VP/02 Pradip Roy left for Putimari, near Kalimandir Math under Bagdogra PS, S.P.C by Govt. vehicle No. WB61A/0137 to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as of the escape of the offender. The matter is diarised in GD vide Bagdogra PS GDE No. 1260 dated 21.11.2025. At around 12:35 hrs we reached at Putimari, near Kalimandir Math and made an ambush there keeping our Govt. vehicle away from the place and had been waited there for source indication. After a while, at around 13:40 hrs the source indicated us and being indication & identification by source we held raid at the house cum shop of the suspect Lata Lohar and managed to apprehend the suspect with the help of accompanying lady Police personnel and interrogated her. On interrogation, she revealed her identity as Lata Lohar, aged 35 years, w/o-Laxman Lohar, resident of Putimari, near Kalimandir Math, PS- Bagdogra, Dist- Darjeeling and introduced herself as the owner of that house cum shop. We disclosed our identity to her and the input we had. We searched for the independent witnesses to be present there as witness during the process of search, seizure, if any. Two independent witnesses named Rana Karmakar, aged 18 years, s/o- Bijay Karmakar (Ph. No. 8250530266) and Rabi Sai, aged 59 years, s/o- Late Kanai Sai, both are residents of Putimari, near Kalimandir Math, PS- Bagdogra, Dist- Darjeeling were present there to witness the process of search and seizure, if any. Then, we searched the house cum shop in presence of the independent witnesses as well as the Police personnel. On search, the above noted
