1. ASI Chandra Prakash Adhikari of Matigara PS, Siliguri Police Commissionerate beg to state that on 25.11.2025 at 23:45 hrs, I received a secret source information that a gang of miscreants were assembled at a vacant land beside Chumta River behind TIPPA Hall at Biswas Colony under PS- Matigara, Dist- Darjeeling with deadly weapons and making preparation for committing dacoity at Pati Colony area under Matigara PS. Accordingly, I informed the fact to you and diarized the matter vide Matigara PS GDE No- 1397, Dated- 25.11.2025. As per kind order at 23:50 hrs myself along with C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Biswas Colony behind TIPPA hall under PS- Matigara, Dist- Darjeeling to work out the information in hand. This refers to Matigara PS GDE No- 1398, Dt- 25.11.2025. At about 00:05 hrs on 26.11.2025 we arrived at Biswas Colony behind TIPPA hall under Matigara PS. After arrival of the spot and as identified by the source we found that 11/12 persons were assembled at a vacant land beside Chumta river behind TIPPA hall at Biswas Colony, PS- Matigara, Dist- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended five (05) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity in a house at Pati Colony under Matigara PS area. They also stated that others 06/07 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 00:10 hrs to 00:35 hrs on 26.11.2025. The whole process of seizure was made under videography and the video was made by C/868 Sujal Roy of Matigara PS, SPC.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely 1] Rabi Gupta (19 yrs approx), S/O- Satya Narayan Prasad Gupta of Simultola, PO+PS- Matigara, Dist- Darjeeling, 2] Dipankar Das (22 yrs approx), S/O- Biswajit Das of Sitala Para, W/No- 31, PS- NJP, Dist- Jalpaiguri, 3] Rajib Dutta (29 yrs approx), S/O- Lt. Rajesh Dutta of Paul Para 9 no Goli, Promod Nagar, PO- New Rangia, PS- Matigara, Dist- Darjeeling, 4] Ranjan Chhetri (32 yrs approx), S/O- Raju Chhetri of Jyoti Nagar Colony, PO+PS- Siliguri, Dist- Darjeeling, 5] Manik Singha (24 yrs approx), S/O- Suresh Singha of Samar Nagar Bottola, PS- Bhaktinagar, Dist- Jalpaiguri and others and arrange for its investigation.
