Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Chhotu Sahani (19 yrs approx), S/O- Bhuneshwar Sahani of Coolie Para near Kiran Chandra Samsan Ghat, W/No- 01, PS- Pradhannagar, Dist- Darjeeling and the following seized articles:

- 1] Twenty Eight (28) cartoons of 'MAGIC MOMENTS' grain vodka each cartoon contain twelve (12) bottle and each bottle contain 750 ml and styled 'FOR SALE IN SIKKIM ONLY' and from which one bottle taken as sample and marked as 'Exhibit- A'.
 - 2] Ten (10) cartoons of 'ROYAL CASTLE' blue premium whisky each cartoon contain twelve (12) bottle and each bottle contain 750 ml and styled 'FOR SALE IN SIKKIM ONLY' and from which one bottle taken as sample and marked as 'Exhibit- B'.
 - 3] Eight (08) cartoons of 'Green Label' whisky each cartoon contain twelve (12) bottle and each bottle contain 750 ml and styled 'FOR SALE IN SIKKIM ONLY' and from which one bottle taken as sample and marked as 'Exhibit- C'.
 - 4] Four (04) cartoons of 'Old Monk' Deluxe Rum each cartoon contain twelve (12) bottle and each bottle contain 750 ml and styled 'FOR SALE IN SIKKIM ONLY' and from which one bottle taken as sample and marked as 'Exhibit- D'.
- in total 450 Liter. The ground of arrest duly been communicated with him.

I, PSI Avijit Banik, of Matigara PS, SPC under your kind control beg to state that on 26.11.2025 at around 12:40 hrs I received a secret source information that one person as noted above has stored liquor illegally at his sister's house at Simultola Baba Loknath Colony, PO+PS- Matigara, Dist- Darjeeling. Accordingly informed to I/C PS and as per his kind direction myself along with ASI Chandra Prakash Adhikai, ASI Dipak Kr. Chhetri, C/523 Sanjit Kundu, C/219 Sanatan Chitrakar, L/C 1316 Chandana Paul all are of Matigara PS, SPC left for Simutola Baba Loknath Colony under Matigara PS to work out the information in hand. This refers to MTG PS GDE No. 1421, Dt- 26.11.2025. At 12:55 hrs we arrived at Simultola Baba Loknath Colony and I met with my source and he briefed me about the detail information and stated that the suspected person would arrive anytime. At about 13:25 hrs, my source identified the suspected person who is approaching towards Simultola Baba Loknath Colony. Accordingly we stood on the road. After a hot chase we managed to apprehend and I detained the above noted person. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he has stored huge quantity of liquor at his sister's (Runa Sahani) house and he will export those to Bihar without her knowledge. As identified by the detained person we search the house of Janak Paswan who is brother in law of the detained person at Simultola Baba Loknath Colony and the above noted liquor were recovered. On demand the detained person failed to produce any documents/license in respect of store/sale of the liquor which were recovered from his sister's house. On being asked the sister of the detained person told they had no idea regarding these matter. Accordingly, I seized the above noted liquor which were found at the house of Janak Paswan from the possession of the detained person under proper seizure list and arrested him under proper memo of arrest and observing all the formalities. The whole process of search, seizure, label & arrest was made in between 13:40 hrs to 14:25 hrs on 26.11.2025. The whole process of seizure was made under videography and in presence of independent witnesses and the video was done by C/219 Sanatan Chitrakar.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Chhotu Sahani (19 yrs approx), S/O- Bhuneshwar Sahani of Coolie Para near Kiran Chandra Samsan Ghat, W/No- 01, PS- Pradhannagar, Dist- Darjeeling and arrange for its investigation.
