With due respect, I am producing herewith 01 (one) arrested person, Kanhaiya Kumar (21 yrs approx). S/O- Raghunar Singh of Iniyer, W/No- 011, PO- Danauli Phulwaria. PS- Lakha, Dist- Begusarai, Bihar and the following seized articles:

- 1] Four hundred and thirty two bottle of 'Old Monk' Deluxe Rum and each bottle contain 750 ml and styled 'FOR SALE IN SIKKIM ONLY' and from which one bottle taken as sample and marked as 'Exhibit- A'.
 - 2] Twenty Six (26) cartoons of 'MAGIC MOMENTS' grain vodka each cartoon contain twelve (12) bottle and each bottle contain 750 ml and styled 'FOR SALE IN SIKKIM ONLY' and from which one bottle taken as sample and marked as 'Exhibit- B'.
- in total 558 Liter. The ground of arrest duly been communicated with him.

I. ASI Dipak Kr. Chhetri, of Matigara PS, SPC under your kind control beg to state that 26.11.2025 at around 16:15 hrs I received a secret source information that one person as noted above has stored liquor illegally at a house at Chandmuni Bara Line-1, opposite side of Ananta Jyoti Church, PO+PS- Matigara, Dist- Darjeeling. Accordingly informed to I/C PS and as per his kind direction myself along with ASI Chandra Prakash Adhikai, C/523 Sanjit Kundu, C/219 Sanatan Chitrakar, C/868 Sujal Roy all are of Matigara PS, SPC left for Chandmuni Bara Line-1 under Matigara PS to work out the information in hand. This refers to MTG PS GDE No. 1435, Dt- 26.11.2025. At 16:30 hrs we arrived at Chandmuni Bara Line-1 and I met with my source and he identified the suspected house which is situated at Chandmuni Bara Line-1 opposite Ananta Jyoti Church under Matigara PS. Accordingly had been at the house and detained the above noted person. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that huge quantity of liquor was stored at this house. As identified by the detained person we search one room and the above noted liquor were recovered. On being asked the detained person also disclosed that the house is belongs to James Xalxo, S/O- Ropna Xalxo and he is a partner of the detained person. The owner of the house namely James Xalxo is found absconding from his house to avoid police arrest. On demand the detained person failed to produce any documents/license in respect of store/sale of the liquor which were recovered from the house of James Xalxo. I searched for independent witnesses but none of them gave their willingness to be present as independent witness. Accordingly, I seized the above noted liquor which were found at the house of James Xalxo from the possession of the detained person under proper seizure list in presence of police witnesses and arrested him under proper memo of arrest and observing all the formalities. The whole process of search, seizure, label & arrest was made in between 16:40 hrs to 17:14 hrs on 26.11.2025. The whole process of seizure was made under videography and the video was done by C/219 Sanatan Chitrakar.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused persons namely 1] Kanhaiya Kumar (21 yrs approx), S/O- Raghunar Singh of Iniyer, W/No- 011, PO- Danauli Phulwaria, PS- Lakha, Dist- Begusarai, Bihar and 2] James Xalxo, S/O- Ropna Xalxo of Chandmuni Bara Line-1. opposite side of Ananta Jyoti Church, PO+PS- Matigara, Dist- Darjeeling and arrange for its investigation.
