Sir,

In producing herewith one (01) arrested accused person namely Niraj Thapa (M/31), S/O Jugdish Thapa of Dom Busty, Biswas Colony, PS. Matigara, Dist- Darjeeling, (not verified) along with the following seized article under proper seizure as per seizure list;

- i) One transparent plastic packet containing 281 grams appears to be brown sugar which was wrapped with a black colour plastic and kept on the left side of jacket pocket of accused Niraj Thapa and marked as "Exhibit- A".
- ii) One white colour Realme mobile phone having IMEI no - 861888068577754/16 & 8991000921603431700 which was found inside right pocket of Jeans Pant of accused Niraj Thapa.

I, SI Basudeb Guha, S/O - Lt. Badal Ch. Guha of Detective Department, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Niraj Thapa (not verified) to the effect that today on 27.11.2025 at about 13.25 hrs I received a specific source input that one person is standing at Pakka Road near Chandmoni Junior Basic Primary School under Matigara PS with huge quantity of Brown Sugar for delivering the same to his designaled customers at the adjacent areas. The matter was diarized in Detective Department GDE No.158, Dt- 27.11.2025 and subsequently, I informed the matter to the ACP. DD. and being directed, myself along with SI Biswajit Ghosh, ASI Sushanta Dey, C/ 562 Utpal Saha, and CV/151 Mantosh Talukder all of DD, SPC along with investigation kit left for Chandmoni Junior Basic Primary School under Matigara PS by govt. vehicle to verify the veracity of the information. This refers to DD. SPC. GDE No. 159, Dt- 27.11.2025 and M.C.C No- 315/25 Date- 27.11.2025.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Chandmoni Junior Basic Primary School near Railway line, I contacted two persons namely 1) Shri Nabin Kuzur (M/36), S/O- Amrit Kuzur of Chandmoni, PO+PS. Matigara, Dist. Darjeeling (9832676684) and 2) Shri Lakhan Beck(M/38), S/O-Lt. Charwa Beck of Chandmoni, PO+PS. Matigara, Dist. Darjeeling(9734980807) and make them aware of the information in hand and requested them to act as witness, during search and seizure if any upon which they agreed. Thereafter we along with the independent witnesses noted above, reached at Chandmoni Junior Basic Primary School under Matigara PS at 13.55 hrs and being pointed by my reliable source approached towards one person standing there. At that time seeing the Police party approaching towards him, he started fled away from the spot but, however we managed to apprehend him. Thereafter, I disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he after disclosing his identity as noted above admitted that he has illegally possessed brown sugar for selling the same to his designaled customers as per their requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. At this he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party. Accordingly, I informed the matter to ACP.DD and as per his kind order, I informed to Shri Anil Roy, Inspector of Police, Detective Department, Siliguri Police Commissionerate, regarding the interception of the accused person suspected to be possessed Brown Sugar and requested him to come at Pakka Road near Chandmoni Junior Basic Primary School under Matigara PS to remain present and to supervise the search and seizure.

Accordingly at 14.15 hrs Shri Anil Roy, Inspector of Police, Detective Department; Siliguri Police Commissionerate arrived at the spot at Pakka Road near Chandmoni Junior Basic Primary School as Gazetted Officer SPC and in presence of two independent witnesses I searched the detained person following all formalities, keeping his decency and recovered the above noted articles from the possession of the accused person namely Niraj Thapa. Further on demand in presence of Shri Anil Roy, Inspector of Police, Detective Department, Siliguri Police Commissionerate the detained person namely Niraj Thapa failed to produce any valid document in support of possessing of the appears to be brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found 281 grams of appears to be brown sugar kept in a transparent Plastic Packet which was wrapped with a black colour plastic and kept on the left side of jacket pocket of accused Niraj Thapa and marked as "Exhibit- A", and One white colour Realme mobile phone. Accordingly, I seized the above noted articles from the possession of accused namely Niraj Thapa at the spot at Pakka Road near Chandmoni Junior Basic Primary School under proper seizure list in presence of independent witnesses and Shri Anil Roy, Inspector of Police, Detective Department, Siliguri Police Commissionerate obtaining their signature and being acknowledged by the accused person. Subsequently, I labeled and sealed the seized articles in presence of Shri Anil Roy, Inspector of Police, Detective Department, Siliguri Police Commissionerate and independent witnesses and the accused person. The whole process of seizure was made in between 14.25 hrs to 14.55 hrs under proper videography.

Being further asked, the apprehend person namely Niraj Thapa admitted in presence of Shri Anil Roy, Inspector of Police, Detective Department, Siliguri Police Commissionerate and other independent witnesses that he has procured the brown sugar clandestinely from Kaliachak/Malda side for the purpose of selling the same in high rate to his signaled customer for his personal gain by illegal means. He also disclosed that he has been dealing in this business of procuring and selling of brown sugar illegally since long for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Niraj Thapa is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Niraj Thapa u/s 35 BNSS and after observing all formalities and informing the ground of his arrest in written and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Niraj Thapa (M/31), S/O Jugdish Thapa of Dom Busty, Biswas Colony, PS. Matigara, Dist- Darjeeling, (not verified) and arrange for its investigation.
