Respected Sir,

I, Chand Tara Khatoon, wife of Mr. Bablu Hussain, residing at Pokhai Jote, Champasari, Ward No. 46, Siliguri – 734003, beg to lodge this fresh written complaint against Mrs. Priyanka Sah, wife of Mr. Mantosh Sah, who stays in the same locality just opposite my residence. Sir, I had earlier submitted a written complaint on 11.11.2023 at your police station regarding the continuous harassment, abuses, false allegations and threatening behaviour of Mrs. Priyanka Sah. Despite the previous complaint and repeated requests from my side, she has again repeated her violent and unlawful actions today.

Today, without any cause or provocation, Mrs. Priyanka Sah once again came near my house and started hurling filthy and abusive language at me. She also began arguing with my mother-in-law unnecessarily. Suddenly, she forcefully entered my house without permission and attacked me. She scratched my face with her nails, bit me, and physically assaulted me badly. While attacking me, she also made baseless allegations and continued shouting and abusing. Her behaviour was aggressive, violent and completely unprovoked. During this attack she even threatened to kill me, which has created extreme fear, shock, and mental stress for me and my family.

Her entry into my home, assault on my body, abusive behaviour, and threats to my life have caused serious physical injury, emotional trauma, humiliation, and danger to my safety. I am living under constant fear because of her repeated acts of violence, and my family is also disturbed and scared due to her aggressive conduct.

Therefore, I earnestly request you to kindly register an FIR against Mrs. Priyanka Sah and take strict legal action for her acts of house trespass, physical assault, causing injuries, criminal intimidation, and continuous harassment so that she may not continue committing such unlawful acts against me and my family. I also request you to ensure my safety and maintain peace in our locality.
