Respected Sir,

I the undersigned would like to inform you that the above-named persons are the committee member and they also running illegal batting ID through online system. They are influenced me to joined the said committee, after several request I joined the said committee. After joining the said committee I came to know that the above-named persons running illegal batting ID through online as well was they also running market share business throughout the Siliguri market. After knowing the aforesaid illegal act, I tried to dismember of the said committee, but they are influenced me to continue the said membership in the said committee without any such payment. As such I continue as a member in the said committee.

After joining the said Committee, the abovenamed persons last one month demanding a sum of Rs. 15,00,000/- (Rupees fifteen lakhs) only. But I strictly denied to give any such money to them, if they are wish to dismember of the said committee as there wish. But they are continuously demanding the said money. Thereafter on 26/11/2025 at about 10:25 P.M. the above-named persons Sri Subham Agarwal, Sanju Agarwal and some antisocial persons visited my residential house and threatening me to give a sum of Rs. 15,00,000/- only within two days otherwise I will face dare consequences and they are also showing me fire arms. Thereafter on 27/11/2025 at about 8.55 P.M. when I was gone to Backalley Snooker Club at Haiderpara the abovenamed persons came to the said club and they told me to came outside the club, they want to talk to me, as such I went to them to talk outside the said club. Thereafter the abovenamed persons started beating me with feast and blow and they are snatching me one gold chain at about 25 Grams. Thereafter they flew away in the said place.

Accordingly, I request you to take necessary action against them and started criminal proceeding for the said illegal act.
