Sir,

I would like to lodge a formal complaint against one Ms. Pinki Giri, contact number 7825816519, for fraud, cheating, and impersonation by falsely claiming herself to be an official of the Siliguri Municipal Corporation (SMC) Trade License Department). It has been reported by several residents and trade license holders within the SMC area that the said person has been calling traders and business owners, introducing herself as an SMC official, and demanding money in exchange for issuing or renewing trade licenses. She has also been sending QR codes via WhatsApp to several individuals and asking them to make payments through digital transfer, assuring them that their trade licenses would be issued or renewed thereafter.

Many traders have already made payments to her under this false representation. Several have also verbally complained to the SMC Trade License Department regarding this fraudulent activity. Preliminary inquiries indicate that Ms. Pinki Giri is not an employee or authorized representative of SMC, and she is fraudulently misusing the name of a government office to deceive the public and extort money.

In view of the above, I request you to register an FIR against Ms. Pinki Giri (Mobile: 7825816519) and initiate an immediate investigation into the matter to prevent further financial loss to the public. Appropriate legal action may kindly be taken to trace the accused and recover the defrauded amounts from her possession.
