I, Sri Annakumar Barman, Son of Late Dinnath Barman, aged about 45 years, resident of Vill: Bara Lachka Jote, P.O. New Rangia, P.S. Matigara, Dist: Darjeeling- PIN-734013 would like to inform you that on 17/11/2025 my son Lakshan Barman (now deceased) aged about 22 years was coming from Bagdogra towards Shivmandir by riding motorcycle bearing No.- **WB-74-BE-1501** when he reached near Gate No 2 University of North Bengal some unknown vehicle hit my son motorcycle from back side at about 07:00 P.M. and my son fell down on the road and sustained injuries. Immediately he was shifted to North Bengal medical College & Hospital where he was declared dead. I was busy with the funeral work of my son so I was unable to lodge the FIR and today I lodge this FIR after 11 days of accident.

Therefore I request you to kindly enquire into this matter and to take necessary legal steps as per law.
