I, ~~Smt.~~ Taniya Biscoas, DO. Chinmay Biscoas, P.O. Narayanpally, Atharakhai, Shivmandir, P.O. & P.S. Matigara, PIN: 734011 want to inform you that today around 8.00 a.m. morning, I went to my Maternal Uncle's house to help my grandmother as she called me over the phone and asked me to go to her house as she is not well and help her to work due to which I went there (at my Maternal Uncle's house) situated at Narayanpally, Near Atharakhai Balika Bidyalaya, P.O. & P.S. Matigara, 734011 but as soon as I reached there, both my Maternal Uncle and Aunt, namely Pintu Roy and his wife Mamoni Roy came towards me and insulted me in a very filthy and bad languages which is totally unsocial in nature but I somehow managed to bear with their's such misbehaviour and I started to work for my Grandmother on the mean time again both Pintu Roy and Mamoni Roy came and caught my hair and pulled my hair and has thrown me out of their home and has brutally assaulted me physically with kicks, fists and blows at that time I was crying and begging them to leave me but such Pintu Roy repeatedly came and pulled my clothes off from my body and has teased it and touched my private parts by saying that I will rape you in front of every body and has also scratched my body parts which has kept me in severe pain. After that I somehow managed to escape from his hand but he again threatened me by saying that I will rape and kill you next time if I see you in front of my eyes and will also throw you out of the reach of your family and police.

Under the above facts and circumstances, I therefore pray before you to take all the possible necessary, strict and penal actions against such criminal and also kindly register a case and also save my life from the hands of such criminals.

And for this act of kindness, I shall forever pray.
