SUBJECT: FIR REGARDING ROAD  
ACCIDENT, PROPERTY DAMAGE AND  
THREATS BY A SCOOTY RIDER  
COMING FROM THE WRONG SIDE.

Sir/Madam,

I, Miss Priyanka Tamang, D/o Sri Kumar Tamang, presently residing at Babubasa, Devidanga, Champasari Road, Siliguri - 734003, respectfully submit this complaint for your necessary action.

On 26.11.2025, at around 4:15 p.m., while I was riding my scooty bearing registration number WB74BT4311 from Jhankar More near fly over towards Air View, one scooty rider bearing vehicle number WB74BG1613 came from the wrong side in a rash and negligent manner and collided with my vehicle. Due to the said collision, my scooty suffered damage and I also sustained shock and minor injury.

When I asked the said rider to take responsibility for the damage caused, he behaved aggressively, and further threatened me with dire consequences. He then attempted to flee without providing any details of his identity.

The above actions of the rider constitute offences punishable under the relevant provisions of Bharatiya Nyaya Sanhita (BNS), 2023, relating to:

- Rash and negligent driving on a public way,
- Causing damage to property,
- Criminal intimidation/ issuing threats.
- Misbehaviour, Insult, Harassment towards a Women.

Therefore, I request you to kindly register my FIR, conduct a detailed investigation, identify the accused rider, and take appropriate legal action as per law as earliest.

I am ready to cooperate with the investigation and provide all necessary information.
