Respected Sir,

I, Saraswati Debi Gupta, W/o Laxman Prasad Gupta, resident of Ward No. 07 of S.M.C., Neheru Road, Khalpara, P.O. & P.S. Siliguri, District - Darjeeling, would like to bring your attention to the facts as listed herein below:

1. That I am residing in the above mentioned address and my father-in-law namely Murlidhar Prasad, Son of Lt. Bachu Prasad, my brother-in-law Ramji Prasad and his wife Saraswati Gupta along with their son Shib Shakti Prasad are residing as my neighbors, our house are adjoining to each other.
2. That the said in-laws frequently pick quarrels with me over trivial and insignificant matters. It is absurd even in thought but the said neighbor start their morning from harassing me over unnecessary things like water in terrace and just any random and insignificant things. Despite my efforts to maintain peace, they continue to behave aggressively and use abusive language.
3. That it is pertinent to mention here that being my in-laws they never accepted me as their daughter, moreover they always creates ruckus and such constant harassment is causing me severe mental and physical trauma.
4. That today morning at around 11:00 A.M. my husband namely Laxman Prasad Gupta was repairing our entrance gate and was

monitoring the work. The aforesaid persons seeing such work started using filthy languages against my husband. After hearing such loud noise me and my daughter namely Sweta Gupta (aged about 28) went to our roof and protested such rude behavior against my husband.

5. The aforesaid accused persons all came in a group and attacked my husband. I along with my daughter rushed to save him. Ramji Prasad and Shib Shakti Prasad hit my daughter at her head with battam repeatedly with sole intention to kill her. I and my husband tried to resist them but we were out numbered. They also hit me and my husband with battam and fist. My daughter got grievous injuries and she started vomiting and blood came from her mouth due to such severe injury at her head. I and my husband also got injuries. After hitting badly they left the spot seeing my daughter vomiting and bleeding from mouth.
6. That my daughter was rushed to Arogya Niketan Hospital by my husband and from there she was referred to District Hospital for further treatment wherein she had been admitted right now under critical condition.

Therefore, I request you to kindly register this FIR against the said neighbor under the appropriate sections of law, and take necessary legal action to ensure my safety and peace of mind.
