Sir,

With reference to the earlier FIR dt 19/11/2025 and several other complaints and follow ups with your good-self office, this is to inform that the local goons namely Sonarul Haque alias bhochok along with several other anti social elements like MD Hasibul having mobile number 9547155193, MD Taffijul having mobile number-9732136290 and others are continuously trying various means to grab our land at Bandhunagar More District: Jalpaiguri in RS plot of land 150 corresponding to LR plot 202 land measuring 87 decimal in mouza Ambari Falakata JL no:21 sheet no.1 having total plot area of 83 decimal as per record of rights prepared by West Bengal land reform department and also duly mutation of the complete area of the LR plot of land is done in the name of Vishal Agarwal, Charu Agarwal and Ujjwal Agarwal vide LR Khatian no. 414,415 and 1129 (**marked as Annexure 'B'**) vide reference purchase deed 3933,3935,3966 all of the year 2011 and deed no 3561 and 6293 of the year 2023 registered at ADSR Raiganj. Moreover there is also a ad-interim injunction restraining the respondents from interfering peaceful possession of the land of the petitioner(us) vide TS340 of the 2019 by the Honorable Court of Civil Judge Junior Division at Jalpaiguri Dt:18/11/2019 & subsequent extension of the same order, latest order date being 25/4/2025 (**collectively marked as Annexure 'B'**)

Now even after several numerous follow-ups at your goodself at Bhorer Aloo Police outpost and to ACP East II Shri Somnath Dhar and DCP East Shri RK Singh no steps have been taken to resolve peace and take necessary action against the alleged people having vicious reason which is resultantly getting converted into big mobs or gangs having criminal impulse.

The above gangsters are trying to grab our land and trying to cause us irreparable damage in our plot of land in LR plot no.202 by showing papers of being part owner of plot of owner of LR Plot No. 204. The LR plot information along with LR plot drawing as per LR Mouza map as per West Bengal land reform department for both LR plot no. 202 and LR plot no 204 is Marked as annexure C.

Sir, we are presently running a Tata Motors Commercial Vehicle showroom cum service centre along with being the only service provider of Tata Advanced Systems ltd providing

repair and over hauling of sensitive vehicle of Army namely QRFV and IPMV loaded with weapons of national security in entire North Bengal and Sikkim.

At the aforesaid mentioned premises now the miscreants of the goons having such villainous motivation have broken the CCTV camera of our showroom and stones are being pelted inside our premises to cause irreparable damages. We have already shared several footages of Land grabbing, atrocities and breaking of cctv camera over whatsapp of the DCP and ACP in-charge but still no action has been taken yet.
