Sir,

I, Vishal Agarwal Director incharge of M/S Laksh Automobiles had entered into a agreement to sale with four number of people namely 1. Jayagun Begum, wife of Bangara Mohammed, 2. Rafik Husen, Son of Ajibaddin Mohammed, 3. Anoyara Khatun wife of Samijaddin mohammed and 4. Umar Ali, son of Bejat Mohammed, residents of Baxabhita, Akarigach, Balaram PS Rajganj, dist: Jalpaiguri-735135 who are claiming to be the joint owner of the piece and parcel of land measuring 112 decimal in RS Plot no. 151 and 152 sheet no 1 of Ambari, Falakata corresponding LR Plot of land 203 and 204.

We have paid an advance of amount of Rs 25000 to each of the vendors, the copy of sale agreement (marked as annexure A). On further enquiry after a few months it was found that the predecessor of the seller had already sold most of the land and there are other legal heirs of the said predecessor being the recorded owner of RS Khatian No. 4/1.

Since then we have constantly followed up with the seller to arrange for providing legal ownership and possession of land as per agreement of sale or else refund the advance amount paid by us along with interest and other terms and condition as per the conditions of the sale agreement but all of them are absconding and not replying neither they are responding to any of my communication efforts, the mobile number after seller is 91108709683, 9083086883 and 9064341047

This is to note that the seller has duped and cheated us by making false representation and promises and has taken advance from us against the land which was already sold by his predecessor. Kindly please request your good-self to register the FIR and take necessary action required as per law.
