Subject: Complaint Regarding Theft of Computer Hardware Components by Company Employee

Respected Sir,

I, **Gitesh Tibrewaal**, Director representing **Logic Fusion Private Limited**, located at 2040/23/24/25, 1st Floor, Kapil Centre, Sevoke Road, Siliguri, hereby lodge this formal complaint regarding a criminal act committed by our employee **Mr. Subhankar Chakraborty S/o Late Shibu Chakraborty**, Aadhar Card No 875142240931, employed as a **Hardware Support Technician** in our organisation.

Details of the Incident

Our company was recently assigned a project for deployment and installation of computer systems at **ITC Fortune Hotel (Fortune Hotel)**, Eastern ByePass Road, Siliguri. During routine checks and verification on **28th Nov 2025**, we found that **five (5) desktop computers** supplied for the project had been **illegally opened during the week**, and critical hardware components—specifically:

5 Processors (CPU units) and 5 RAM modules

were **removed, stolen, and subsequently sold in the local market** by the said employee.
