Subject: F.I.R

Sir,

In producing herewith the following one accused person namely Kanhaiya Ram (M/35) S/O Late Sitaram Ram of Lutiyaajote, P.S. Matigara, Dist. Darjeeling under arrest and the following seized articles viz:- (i) One vehicle (Truck) bearing Registration number WB 76A BP 3610 loaded with illegal river bed materials, (ii) 06 (six) nos of Belchas and (iii) one key of the vehicle under proper seizure list,

I, SI Bijay Sarkar of Pradhan Nagar P.S/SPC do hereby lodge this complaint against the above noted arrested accused person namely Kanhaiya Ram (M/35) S/O Late Sitaram Ram who is also the owner of the seized vehicle to the effect that on 28.11.25 at 12.05 hrs I received and information from my source that one vehicle loaded with illegal river bed materials was coming from Panchanoi River Ghat, Dagapur side towards main road i.e. NH 110. The matter was diarised and I informed the fact to you over mobile phone and as per your kind order and direction myself along with force left P.S to conduct a raid vide PDN P.S GDE No 1634 dated 28.11.25. Accordingly, I along with force in Govt. Vehicle arrived at Dagapur at around 12.20 hrs and received specific information from my source that the truck bearing Reg. No. WB 76A BP 3610 loaded with illegal River bed materials was coming towards Viramma Resort side from the Panchanoi River under P.S Pradhan Nagar, Dist. Darjeeling without any valid documents. At around 13.05 hrs near Viramma Resort, Dagapur under Pradhan Nagar P.S I detained the said tractor displaying number plate WB 76A BP 3610 loaded with illegal River bed materials and also found that the driver was inside the cabin of the said truck. On being asked he disclosed his name and identity as noted above. On demand he failed to produce any documents in respect of the river bed materials loaded in his vehicle. On further interrogation he disclosed that he himself is the owner of the vehicle and he mines such river bed materials from Panchanoi River by illegal means with a view to sell the same to his designed customers for his illegal gain since long. Accordingly, I seized the above noted vehicle having registration number WB 76A BP 3610 loaded with illegally mining river bed materials under proper seizure and subsequently I arrested him stating him the ground of arrest in written and maintaining all formalities of arrest and brought to Pradhan Nagar PS for further investigation. The seizure was made in between 13.25 hrs to 13.45 hrs at the spot under the coverage of videography in e-sakshya portal and generated certificate also.

Under the above noted facts and circumstances, I therefore, pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Kanhaiya Ram (M/35) S/O Late Sitaram Ram of Lutiyaajote, P.S. Matigara, Dist. Darjeeling of the said seized vehicle and make arrangement for its investigation.
