Respected Sir/Madam,

My name is Vidur Gupta, ^{son of - Jai Kant Gupta} a resident of Netajipally, Shivmandir, delivery partner at Blinkit (Partner ID F7470352). I am writing to lodge a complaint regarding a physical assault on me by the staff of Blinkit Super Store Siliguri Junction S156, located at 141/37/1/50/A, M.N.S. Sarani, Bye Lane, Pradhan Nagar, Ward No. 02, Siliguri.


I started working at this store on 26 November 2025. After midnight on 27 November 2025, (early hours of 28th, around 12:05 a.m.), the store manager told me that he would not allow me to deliver from 12 AM to 6 AM, claiming "this is his store and he will only allow a set of specific riders to make deliveries". I asked him to provide this directive in writing, which he refused. The other employees threatened me after this and then when I asked them to talk properly they charged up towards me and started physically attacking me and assaulting me.

I immediately called emergency number 100, and a police patrol arrived. My reference number for that call is 242218. The police personnel noted the names of the manager and the employees involved.


Due to the assault, I sustained injuries including swelling under my eye, scratches on my face, and an injury on my right knee. I visited the Government Health Centre, Matigara, and have the medical injury report, which I am submitting along with this complaint.

I request you to kindly register an FIR under the appropriate sections for assault, criminal intimidation, and wrongful restraint, and initiate immediate action. I also request that the CCTV footage of the incident from the store be preserved and seized as evidence.
