Subject: Written Complaint

Respected Sir,

I am the lawful constituted attorney of Smt. Lilawati Devi, wife of Dara Prasad, resident of Telipatta, Post Office & Police Station- Porompat, East Imphal, Manipur, PIN-795001, would like to bring the following facts to your kind notice:

That Smt. Lilawati Devi is the sole and absolute owner of vacant land measuring 12 decimals or 7 Kathas 5 Chattaks, appertaining to and forming part of R.S Plot No. 124, corresponding to L.R. Plot No. 280, recorded in L.R. Khatian No. 1540 and new L.R. Khatian No. 2183, situated within Mouza- SISHABARI, J.L. No. 41, Pargana: Patharghata, under Champasari Gram Panchayat, Additional District Sub Registrar at Siliguri- II at Bagdogra, Police Station: Pradhan Nagar formerly Matigara, Sub Division- Siliguri, District: Darjeeling, West Bengal by virtue of a Deed of Conveyance and the said Deed was registered on 25/06/2014 at the Office of the D.S.R. Darjeeling, Being No. 00711 for the year 2014 from Sri Nath Narayan Sahu, Son of Late Ram Lochan Sahu.

That after purchasing the below-scheduled land the above-named owner constructed a boundary wall measuring 3 feet in height. On 28/07/2025, the owner along with her husband, visited the said land and observed that due to the rainy season and heavy rainfall certain portions of the boundary wall had been damaged.

That today as per the instructions of the above-named owner when I visited the said land I noticed that 3/4 miscreants/trespassers had constructed a tin-shed room on the below-scheduled land. I immediately asked them why they had constructed the tin-shed room on the said property. They responded by using filthy and abusive language and threatened me with dire consequences if I attempted to stop them or question them. On protest they physically assaulted me with kicks and blows and threatened to kill me. I apprehend that the above-named persons are dangerous persons and they will encroach the below-scheduled property.

It is also pertinent to mention here that I apprehend that they have procured some forged and fake documents and on the basis of those forged and fake documents they have encroached the below-scheduled land.

It is, therefore requested to take appropriate legal action the above persons and further requested to protect the below scheduled land. Hope you will do the needful favourably at the earliest.
