Sir,

I, Lakhi Darnal, wife of Late Kamal Kumar Darnal, resident of Dakshin Palash, near PHE Pump House, Kalkut, Debidanga, request you to register an FIR regarding a house theft that occurred at my residence.

On 28.11.2025, between 01:30 p.m. and 8:30 p.m., unknown person(s) unlawfully entered my house and stole gold jewellery and other valuable household items. I had left home around 01:30 pm to pick my granddaughter from the school drop off point at Debidanga and went directly to meet my mother who resides at Babubasa, Champasari. I discovered the incident upon returning home around 8:30 p.m along with my daughter and granddaughter.

The stolen items include:

- (1) 2 necklaces, 2.5 tola each
- (2) 6 gold bangles, 1.5 tola each
- (3) 1 gold necklace, 6.8 gms
- (4) Gold chain, 1 tola
- (5) 5 gold pendants
- (6) Other gold items like ear rings, coins along with cash amount of Rs. 80,000/-.

I had informed the police control room over the phone on 28.11.2025 at around 22.07 pm by registering the complaint at 112, complaint was registered with id : 242773 from the mobile no 9874799171, after noticing the theft. I now request formal registration of the case.

Kindly take necessary action to investigate the matter and recover the stolen items.
