with due respect I am Dishu Prasad @ Berman (F/22 yrs) W/O Priyanka Prasad resident of South Bagajathi colony, ward no 3, near J.C. club, Vivekananda school, Siliguri, West Bengal, Darjeeling. would like to inform you that yesterday on 30/11/25 at around 22:15 hrs my husband and brother in law were quarreling between each other suddenly after 15 minutes i.e. 22:30. three persons namely ① mukesh Gupta ② Khedar ③ Sanjay Singh ④ Kishor Kathor we are neighbour of my (South Bagajathi colony near Vivekananda school) attack upon my husband and brother in law without any reason. The alleged person tried to kill my brother in law by tying a rope around his neck and beat my husband with bamboo stick on face badly. By seeing this I came out from house and tried to protect them, at that time above mentioned person's kick me on stomach and my body. They tried to touch my body and push me on the fell in wrong intention. later when I fell on the road they started kicking me on face. They forcefully pull my hair, which caused a lot of pain. Due to this I got a sustained injury. They threatened us that "Abhi to kuch nahi hai aur jada karoge to agle jaan se mar denge Hum log a koi kuch nahi kar sakte hai".

Hence I pray before you may kindly consider any requisitions/Prayer and take a necessary action against them. I also request you kindly save us from those Peoples.
