We, (1) Mukesh Gupta, Son of Banarsi Gupta, (2) Kishan Kumar, Son of Ram Naresh Singh, (3) Sanjay Singh, Son of Niranjana Singh, all residents of Gurung Basti, Near Vivekananda School, P.O. & P.S. Pradhan Nagar, District – Darjeeling, Pin – 734003, would like to draw your immediate attention upon the following fact stated herein below.

1. That on 31-11-2025, at around 10:30 p.m., while returning back to our individual homes, we heard our neighboring residents shouting and fighting among themselves. Those people were, namely, (i) Sri Manish Prasad, Son of Late Bijay Prasad, (ii) Sri Penho Prasad, Son of Late Bijay Prasad, (iii) Smt. Basanti Prasad, Wife of Late Bijay Prasad, and (iv) Smt. Disha Prasad, Wife of Penho Prasad. We all witnessed that, the said Basanti Prasad and Smt. Disha Prasad were being beaten mercilessly by the said Manish Prasad and Penho Prasad. Furthermore, the said Manish Prasad and Penho Prasad were also badly hurt and injured from fighting among themselves.
2. That upon witnessing such incident, we rushed to stop them from fighting among themselves. Upon nearing to them, it came to our knowledge that, the said Smt. Basanti Prasad and Smt. Disha Prasad were badly hurt, and the said Manish Prasad and Penho Prasad, were in intoxicated nature and totally drunk.
3. That while we trying to stop them from fighting, they all started to attack us with fists and blows, furthermore, the said Smt. Disha Prasad and Smt. Basanti Prasad started to bite and scratch us. Moreover, the said Manish Prasad and Penho Prasad picked one wooden stick each and started to hit us mercilessly.
4. That we however pushed them away and tried to save ourselves, and also started to shout for help from nearby people. After such chaos and shouting, people from nearby houses came to intervene and saved us from them.
5. That the said Manish Prasad and Penho Prasad threatened us with dire consequences, if we ever come across them; thereafter, the said

- Basanti Prasad and Disha Prasad also threatened us that, they will lodge a false complaint against us to harass us publically.
6. That as we were hurt, we thought not to argue and somehow managed to escape from the place of incident.
 7. That nearby people who had come to rescue us told that they frequently fight among themselves and create nuisance in public places.
 8. That we fear that, the said Sri Manish Prasad, Sri Pesho Prasad, Smt. Basanti Prasad, and Smt. Disha Prasad, shall again create some nuisance and try to physically harm us.

Therefore, we beg before you, to kindly do the needful and take appropriate action(s) against the said Sri Manish Prasad, Sri Pesho Prasad, Smt. Basanti Prasad, and Smt. Disha Prasad, as per the law. Further, we also pray before your office, and also to safeguard us from their illegal intentions of causing us physical harm, and any other necessary action(s), for the ends of justice.




