Respected Sir,

I, **Pradip Sarkar**, S/O. Prasanna Kumar Sarkar, resident of Ramkrishna Nagar, Ward No.47 of SMC, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, beg to report you the following facts:-

1. That on 19.11.2025 at about 12:30 a.m. when I was going to N.J.P through laketown road at that time some 5 - 7 persons negligently parked their bikes on the middle of the road. On reaching there seeing that I stopped my car and requested them for giving some space, so that I might pass from there, but they did not pay any attention to my request as they were in full of drunken condition and were busy in gossiping with each others, seeing the situation I started to manage myself and tried to made some space by shifting their bikes aside the road. Seeing this those persons became violent and started abusing me in filthy and offensive languages, when I protested as to why they without any cause abusing me at that time they became violent and started assaulting me by fists and blows and by kicks, seeing this any how I manage the situation and returned to my house silently, without saying anything to them. The name of those miscreants are (i) **Noni Dhar**, Son of not known, (ii). **Sudip Chakraborty**, Son of not known and more 5 person whose name and address are not known to me.

Sir, it is to be mentioned here that those persons assaulted me and broke my front windshield and back glass of my car, taking the advantage of darkness (midnight) and my loneliness.

It is to be mentioned here that they assaulted me by alleging that I dashed and damaged their bikes from my car, but it is totally wrong, my car never touched / damaged their bikes.

2. That due to confusion and fear I could not lodge any complaint against those miscreants in due time.


I, therefore, request you to kindly take necessary legal action against the aforesaid persons for the commission of the aforesaid offences by them upon me.
