Subject: GD entry regarding verbal abuse and professional insult while on ECI duty as BLO

Sir,

I, Sri Subrata Kall, serving as a Booth Level Officer (BLO) of 26/230 Part, appointed by the Election Commission of India (ECI), would like to lodge this General Diary entry for your kind record and necessary action.

On 9th November 2025, while I was performing my official BLO duties and visiting the residence of Mr. Nirmal Biswas, S/O Nikil Biswas & Madhabi Biswas, located at Deshbandhu Para, Satyen Bose Road, I was subjected to verbal insult and humiliation.

At the time of my visit, Mr. Nirmal Biswas was intoxicated and behaved in a highly disrespectful and abusive manner. He insulted my official capacity as a BLO by uttering — "Get out from my house" — in a derogatory tone, thereby dishonoring the dignity of my profession and the authority of the Election Commission of India.

Furthermore, his conduct not only insulted me personally but also disrespected all BLAs working under the Election Commission in good faith and public service.

I request you kindly to take note of this incident and keep this GD entry for record and future reference.
