Subject: Lodging of FIR regarding physical assault & attempt to murder.

Respected Sir/Madams,

I, Mr. Sanjay Sharma (Event Manager) resident of Swamiji more, Najrul Sarani, Ashramysara Siliguri would like to lodge complaint regarding a serious incident of assault that took place on 30th November 2025, around 02:00 to 3:00 AM at Uttarbangga Marwadi Bhawan, Seroke road, Siliguri.

On the above mentioned date I, Mr. Sanjay Sharma was physically assaulted by the family guests / members of Mr. Rabi Ranjan Prasad (Groom) ~~and~~ Mr. Suresh Prasad (the Mani Ranjan Kumar (Younger brother of Groom), Mr. Avinash Kumar (relative of Groom) and other family members / guests without any provocations. During the assault, the accused person badly injured me like they are attempting to murder, on that particular time my personal belonging (cash amount of 40,000/-, 01 Gold ring & 01 wrist watch) was missing. After committing the offense, the accused persons fled from the spot.

I, Mr. Sanjay Sharma suffered severe injuries and has been taken for medical treatment. This incident has caused tremendous physical & mental trauma to me. Therefore I request you to kindly register an FIR under relevant section of Indian Penal Code relating to assault & attempt to murder, voluntarily causing hurt and take strict legal action against the accused persons involved in this criminal act. I'm ready to provide any further details required during the investigation. Kindly treat this matter urgently in the interest of justice.
