Subject: Complaint regarding theft at my residence

Respected Sir/Madam,

I, Biswajit Das, S/o Binoy Das, resident of Near State Guest House, Ganesh Ghosh Colony, P.O. & P.S. Pradhan Nagar, Siliguri - 734003, would like to lodge a complaint regarding a theft that occurred at our residence.

On 6th December 2025, during between 1:30 AM to 6:00 AM, unknown person(s) broke the bamboo wall (byara er ghera), entered our house, and stole the silver Lord Baba Loknath idol from our mandir. This silver Lord Baba Loknath idol had been established in our mandir for the past 20 years. We believe that Lord Baba Loknath is present in the idol, so we worship it daily and yearly. We have a separate mandir inside our house.

Around 6:00 AM, my mother woke up and saw that the mandir door was open. She saw that the silver lord Baba Loknath idol was missing. One box (a trunk made of tin) had been opened, and all the puja items were scattered around. She called me, and I immediately woke up, saw the same situation. I then called the police. My mother also called our neighbours, and they came and witnessed everything.

The stolen lord silver Baba Loknath idol weight approximately 1 kg, and its market value is around ₹2 lakhs.

Two days ago, my father heard the sound of someone trying to break the lock of the shop near our house. He shouted "chor chor", and the unknown person(s) ran away.

A few months ago, while I was working at night, I heard the sound of someone breaking the lock of the shop next door. I went outside and saw two people attempting to break the lock. I shouted, and my father woke up and came outside, after which the unknown person(s) fled.

Therefore, I request you to kindly investigate the matter and take necessary action against the offenders.
