Sir,

With due respect, in producing herewith 03 (Three) arrested accused persons namely 1) Md. Azad Ansari (M/22 years) S/o-Md. Shahid Ansari of Vivekananda Nagar, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling, 2) Md. Arman (M/23 years) S/o-Md. Ansari of Vivekananda Nagar, Koila Depo, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling and 3) Karan Paswan (M/24 years) S/o-Suman Paswan of Vivekananda Road, Swaminagar Colony, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling along with the following seized articles i.e.

- i) 01 (one) iron made rod length approx 82 cm found from the conscious possession of Md. Azad Ansari (M/22 years) S/o-Md. Shahid Ansari of Vivekananda Nagar, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling
- ii) 01 (one) iron made rod length approx 63 cm found from the conscious possession of Md. Arman (M/23 years) S/o-Md. Ansari of Vivekananda Nagar, Koila Depo, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling
- iii) 01 (one) steel made rod length approx 105 cm found from the conscious possession of Karan Paswan (M/24 years) S/o-Suman Paswan of Vivekananda Road, Swaminagar Colony, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling.

I, PSI Mrityunjoy Kundu, S/o-Sri Madhab Kundu of Khalpara TOP-II under Siliguri PS/SPC do hereby lodged this complaint against accused persons 1) Md. Azad Ansari (M/22 years) S/o-Md. Shahid Ansari of Vivekananda Nagar, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling, 2) Md. Arman (M/23 years) S/o-Md. Ansari of Vivekananda Nagar, Koila Depo, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling and 3) Karan Paswan (M/24 years) S/o-Suman Paswan of Vivekananda Road, Swaminagar Colony, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling and 08/09 (Eight/Nine) others to the effect that on 04/12/25 at about 00.20 hrs during my K-27 night mobile van duty received a reliable source information that some 11-12 persons have assembled in an open place at Ghosh Para, ward no. 07 of SMC under Siliguri PS equipped with dangerous weapons suspected to have been preparing to commit dacoity. Accordingly, the matter was informed to O/C Khalpara TOP-II and the fact had been diarized vide Khalpara TOP-II (under Siliguri PS) GDE no. 87, Dated. 04/12/25 and then as per kind direction of O/C Khalpara TOP-II myself accompanied by SI Newton Biswas, SI Chiranjit Saha, ASI Inzamamul Hoque, ASI Dilip Sarkar, C/1543 Rahul Horijon, C/244 Samim Ali, C/390 Sujit Paul, C/1565 Santu Barman, C/1561 Sandip Modak all of Khalpara TOP-II under Siliguri PS/SPC left for Ghosh Para, ward no. 07 of SMC under Siliguri PS to work out the veracity of source information.

On the way to Ghosh Para, ward no. 07 of SMC under Siliguri PS, I contacted two independent witnesses namely (1) Md. Azmat (M/30 yrs) S/o-Md. Zamir of Vivekananda Road, Khalpara, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling and 2. Md. Taukir (M/22 years) S/o-Md. Zafir of Vivekananda Road, Koila Depo, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling make them aware about the information and requested them to act as witnesses, if any search and seizure would be made necessary on which they agreed.

Thereafter, we along with the independent witnesses noted above reached at Ghosh Para, ward no. 07 of SMC under Siliguri PS and being pointed by the source cordoned off the suspected persons with strong reason to believe that they were preparing to commit some cognizable offence. Seeing police personnel they started to flee away but somehow on hot chase we managed to apprehend the above noted 03 (three) accused persons along with the above mentioned articles. However other 08/09 (Eight/Nine) accused persons managed to flee away from the spot taking the advantage of darkness.

On interrogation the apprehended accused persons admitted that they had assembled along with 08/09 (Eight/Nine) others to commit dacoity in a house at Ghosh Para, ward no. 07 of SMC under Siliguri PS. I therefore, seized the previous mentioned weapons under proper seizer list duly signed by the witnesses and acknowledged by the accused persons. The whole search and seizure was made in between 00.55 hrs. to 01.25 hrs. and the whole process of seizure is video-graphed. Thereafter I arrested the accused persons under proper memo of arrest duly signed by the accused persons. The ground of arrest has been duly communicated with them in written.

Under the above noted facts and circumstances, I pray before you that a specific case under proper sections of law may kindly be started against the accused persons namely 1) Md. Azad Ansari (M/22 years) S/o-Md. Shahid Ansari of Vivekananda Nagar, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling, 2) Md. Arman (M/23 years) S/o-Md. Ansari of Vivekananda Nagar, Koila Depo, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling and 3) Karan Paswan (M/24-years) S/o-Suman Paswan of Vivekananda Road, Swaminagar Colony, Ward No-7 of SMC, PS Siliguri, Dist. Darjeeling and other 08/09 (Eight/Nine) accused persons and arrange for its investigation.
