I, Rosie Subba, daughter of Pitam Subba and a permanent resident of Pudung Basti, District Kalimpong - currently residing at Gurlung Busty, Siliguli, Thana Pradhan Nagal, would like to file a formal complaint against an unknown person, herein referred to as accused.

On December 8, approx. around 4:30 pm, I was travelling back home from my office alone. When I reached Champasali, this accused sat next to me. While the toto was on its way, he started asking me personal questions (What my name is? Where am I from?) I got disturbed and ignored him.

He then wrapped his hand around my waist. I was extremely uncomfortable and traumatised. The toto driver also warned him to mind his own business. But he threatened him, stating he is from the army and the media..

I choose to get down, he then started to follow me and pulled me towards him, trying to physically abuse me and started to record me from his phone. He used derogatory words like "Nepali girls like you are like this only".

When I reached Nivedita Road, Pradhan Nagar,
I went to a local shop asking the shopkeeper
to help me. He abused the shopkeeper and
said - he was from the media.

Then the shopkeeper called the police and the
crowd gathered.

Even when he was at the station, he was threatening us.

I am deeply traumatised by his incident
and has caused me serious mental pain.

I request your esteemed office to kindly
accept my complaint and investigate the matter
so that no other women experience the same.
