In producing herewith following five accused persons named (i) Prakash Tigga, aged 29 years, s/o- Kalu Tigga, resident of Vistijote, PS- Bagdogra, Dist- Darjeeling, (ii) Rahul Biswakarma, aged 18 years, s/o- Late Arjun Biswakarma, resident of Sri Colony, PS- Bagdogra, Dist- Darjeeling and (iii) Shubham Panna, aged 24 years, s/o- Late Biren Panna, resident of Vistijote, PS- Bagdogra, Dist- Darjeeling, (iv) Raju Minj, aged 28 years, s/o- Velsing Minj, resident of Kadopani TE, Church Line, PS- Bagdogra, Dist- Darjeeling and (v) Firoj Toppo, aged 27 years, s/o- Jahara Toppo, resident of Vistijote, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

- (i) One iron-made knife (Kalam chhuri) measuring total length 19 inches including wooden handle measuring length 7 inches and iron made body part length 9 inches seized from the possession of accused Rahul Biswakarma and marked as Exhibit-A.
- (ii) One backpack styled as "MEOW" seized from the possession of accused Prakash Tigga and marked as Exhibit-B.
- (iii) One nylon rope measuring length 15 feet seized from the possession of accused Prakash Tigga and marked as Exhibit-C.
- (iv) One iron made hammer seized from the possession of accused Raju Minj and marked as Exhibit-D.
- (v) One iron made rod measuring length 25 inches seized from the possession of accused Shubham Panna and marked as Exhibit-E.
- (vi) One torch light seized from the possession of accused Firoj Toppo and marked as Exhibit-F.
- (vii) One screw driver seized from the possession of accused Firoj Toppo and marked as Exhibit-G.

I, ASI Amit Lama of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested five involved accused persons and other 3/5 absconding unknown miscreants to the effect that today on 01.12.2025 at 23:35 hrs I received reliable source information that a group of 9/10 suspects have beside NH-27 near Khanna hotel under Bagdogra PS with a preparation to commit dacoity at Bagdogra Bihar more area. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I formed a raiding team consisting SI Binup Mahato, ASI Munna Ahmed and C/1509 Sourav Roy Sarkar led by me. Then we left for NH-27 near Khanna hotel under Bagdogra PS by Govt. vehicle No. WB61A/0137 to work out the secret source information. This refers to Bagdogra PS GDE No. 48 dated 01.12.2025. On the way I contacted with night K-36 mobile van officer ASI Hari Kishor Roy to accompany with us at the above noted PO. Then Hari Kishor Roy along with force C/778 Kamal Lama & C/336 Gobardhan Roy accompanied with us. At around 00:55 hrs we reached beside NH-27 near Khanna hotel and made an ambush there and waited for source indication. We parked our Govt. vehicle away from the place. After a while, source indicated us the place where the group of suspects assembled. There were a group of about 9/10 suspects beside NH-27 near Khanna hotel. Then, being shown & indication by source we started to cordon them from all side. All of a sudden, some of them noticed us and tried to flee away from the spot. But after hot chase with the help of accompanying Police team we managed to apprehend five suspects there in red-handed at around 00:14 hrs. We searched for independent witnesses. One independent witness named Mukesh Ray, aged 29 years, s/o- Biren Ray, resident of Singhijhora TE, PS- Bagdogra, Dist- Darjeeling (Ph. No. 7586838764) was present there. Accordingly, I arranged to search their persons in presence of the independent witness as well as the Police witnesses. On search, one iron-made knife (Kalam chhuri), one backpack, one nylon rope, one iron made hammer, one iron made rod, one torch light and one screw driver were recovered from their joint possession. Accordingly, I interrogated them. On interrogation, they could not give any satisfactory answer regarding their presence at that place at the odd hours of
